

## RFK REPORT - 6/16/76

FORMER D-A SPECIAL COUNSEL TOM KRANZ HAS TOLD ME THAT
HE HAD ONLY LIMITED ACCESS TO LAPD'S S-U-S FILES WHICH
DEAL WITH THE RFK MURDER. HE SAID THAT DURING HIS 4MONTH STINT AS SPECIAL COUNSEL, HE SAW MAINLY SUMMARY
REPORTS AND VERY LITTLE RAW DATA, SUCH AS HANDWRITTEN
NOTES. KRANZ SAID THAT WHILE HE WAS NOT CUT OFF OR
DENIED SPECIFICALLY, HIS ACCESS WAS LIMITED TO THE EXTENT
OF WHAT HE WAS INTERESTED IN, AND THAT TURNED OUT TO BE
MAINLY BALLISTICS DATA TO TRY AND ANSWER THE LINGERING
QUESTION, 'WAS THERE A SECOND GUN?' FOR EXAMPLE, KRANZ
POINTED OUT THAT NO ONE HAD EVER BROUGHT THE REPORT BY
FBI AGENT GRINER TO HIS ATTENTION WHICH ONLY SURFACED THIS
PAST WEEK. THE GRINER REPORT SEEMS TO INDICATE THE
POSSIBILITY THAT TWO MORE BULLET HOLES WERE FOUND THAN
COULD HAVE BEEN FIRED FROM SIRHAN'S GUN.

ALSO INTERESTING AND SOMEWHAT ODD IS INFORMATION FROM SCOURCES AT THE SCENE THAT A COMMUNICATIONS BLACKOUT GRIPPED LAPD'S TWO MAJOR TACTICAL FREQUENCIES RETWEEN 2:30 AND 2:40 AM THAT MORNING. WAS IT AN INNOCENT AND SIMPLE TECHNICAL BREAKDOWN, AND WHY HAS IT NEVER BEEN ACKNOWLEDGED BY POLICE?

AS POLITICS '76 THUNDERS ON AND INTO THE HOME STRETCH...ETAILS ON SUCH INFORMATION REMAINS LOCKED AWAY IN LAPD'S INTELLIGENCE FILES, FUELING CONTINUED SPECULATION OF A CONSPIRACY ON THAT CALIFORNIA PRIMARY MORNING 8 YEARS AGO.
