

REASONS FOR REQUEST OF  
ELECTRONIC SURVEILLANCE AUTHORIZATION



SECURITY PURPOSES INTENDED TO BE SERVED BY  
SURVEILLANCE WHEN INSTITUTED AND PERIODICALLY CONTINUED

The security purposes intended to be served by this surveillance were to determine the extent of communist influence on King, the Southern Christian Leadership Conference, and the racial situation in general. By his activities, King had become recognized by many as the "national leader" of Negro civil rights and the integration movement.

INFORMATION CONCERNING WHETHER OR NOT COVERAGE WAS  
MONITORED ON DIFFERENT SURVEILLANCES ON THE SAME PREMISES

No other coverage was monitored on different surveillances on the same premises.

NATIONAL SECURITY DANGERS WHICH COULD RESULT  
FROM DISCLOSURE OF SURVEILLANCE TO THE DEFENSE

Though this electronic surveillance has been discontinued, its disclosure to the defense would be prejudicial to national security interests since pertinent data developed regarding the activities of the CPUSA would be revealed.
