President's Commission on the Assassination of President Kennedy

Reference is made to Inspector Kelley's l. d. phone call this date relative to a "WANTED FOR MURDER KHRUSHCHEV" notice that appeared in Dallas in the summer of 1963.

SA Roger C. Warner contacted the Criminal Intelligence Section, Special Service Bureau, Dallas, Texas, Police Department this date, June 15, 1964, and found that they had only one of these notices or posters which had been placed on a window of the H. E. Moses Store in the Wynnswood Shopping Center (southwest of downtown Dallas) by an unknown person. It was recovered by the police on August 31, 1963. There were reports of several others in the area but the investigating officer could find no witnesses to the act.

There is enclosed a copy made from the poster described above. SA Warner stated that the specimen which the Criminal Intelligence Section of the Dallas Police Department appeared to be a copy also. It will be noted that the picture of Khrushchev did not reproduce very well. There is also enclosed a copy of Detective W. S. Biggio's report (DMT 2953-1) dated September 12, 1963, in re to this poster. The CIS of the Dallas Police Department desired retain their (copy:1

SA Warner heard that some of these posters showed up in Houston so phone call was made to SAIC Bertram to see if he could find any of the posters there and if so to airmail same to Inspector Kelley. Later SAIC Bertram phoned and stated that insofar as he had been able to learn that none of these posters showed up in Houston; that State Senator Henry B. Gonzales had story in the Houston Post of 1-24-64 re information obtained by The Group Research Corporation (location not shown) which mentioned about the same information as is contained in the last paragraph of Detective Biggio's report of September 12, 1963, as having come from the Dallas Morning News of November 12, 1961 which was a syndicated story from the New York Times News Service.

FULL NAME: Nikita S. Khrushchev. DATE OF BIRTH: 1894, in Kalinovka, Ukraine. FORMER OCCUPATIONS: Sheepherder, blacksmith, locksmith, coal miner. PRESENT OCCUPATION: Professional assassin, executioner and murderer. Khrushchev is currently employed as dictator of Communist Russia, and is directly responsible for the enslavement and degradation of hundreds of millions of Russians, Poles, Rumanians, Hungarians, Latvians, Germans, Lithuanians and others.

CRIMINAL RECORD

NIKITA KHRUSHCHEV (alias "The Hangman of the Ukraine", alias "The Butcher of Budapest") WAS ONE OF STALIN'S PRINCIPAL HENCHMEN FOR MANY YEARS AND PRESIDED OVER THE EXECUTION OF AN ESTIMATED 400,000 VICTIMS IN THE UKRAINE IN THE YEARS OF 1938 and 1939. MASS GRAVES UNCOVERED BY THE GERMAN ARMY IN 1943 YIELDED, BY ACTUAL COUNT, THE BODIES OF 9,439 OF KHRUSHCHEV'S VICTIMS. AFTER WORLD WAR II KHRUSHCHEV IMPRISONED, EXECUTED OR DEPORTED 3,000,000 UKRAINIANS IN ONE OF HISTORY'S MOST COLD BLOODED AND INHUMAN PURGES.

KHRUSHCHEV IS RESPONSIBLE FOR THE DEATH OF NUMEROUS AMERICAN AIRMEN SHOT DOWN BY RUSSIAN PLANES IN RECENT YEARS. HE IS A CONFIRMED WAR CRIMINAL WHO OPENLY AND PERSISTENTLY THREATENS WORLD PEACE WITH COMMUNIST AGGRESSIONS AGAINST PEACEFUL NATIONS. HE HAS REVEALED A FANATIC DETERMINATION TO ENSLAVE THE UNITED STATES, AND ULTIMATELY THE WORLD, UNDER A COMMUNIST YOKE.

CAUTION

TRICKERY AND DECEIT ARE KHRUSHCHEV'S TRADE-MARKS. HE IS NOTED FOR HIS TREACHERY, AND IS MOST DANGEROUS WHEN HE EXTENDS HIS HAND IN PRETENDED FRIENDSHIP. HE BEGAN THE UKRAINIAN PURGES OF 1938 BY INVITING PROMINENT UKRAINIAN LEADERS TO A FRIENDLY CONFERENCE WHERE THEY WERE TREACHEROUSLY ARRESTED AND EXECUTED. EIGHTEEN YEARS LATER, IN 1956, HE INVITED THE LEADER OF THE HEROIC HUNGARIAN REVOLT, PAL MALETER, TO A MEETING UNDER A FLAG OF TRUCE WHERE HE WAS BRUTALLY MURDERED. KHRUSHCHEV LIKEWISE LURED THE HUNGARIAN PREMIER, IMRE NAGY, OUT OF HIDING UNDER PROMISE OF SAFE CONDUCT, ONLY TO BETRAY AND MURDER HIM. IN THE KREMLIN, KHRUSHCHEV LURED HIS FELLOW ACCOMPLICE ON THE POLITBURO, LAVENTIA BERIA, TO HIS DEATH IN A SIMILAR MANNER. KHRUSHCHEV'S COMPULSIVE EMPLOYMENT OF TREACHERY AS A MEANS OF GAINING HIS GOALS INDICATES THAT HE IS AN EXTREMELY VICIOUS CRIMINAL WHO SHOULD UNDER NO CIRCUMSTANCES BE TRUSTED.

MINUTEMEN

Sir:

The attached poster was placed on a window of the M.E. MOSES STORE in the WYNNEWOOD SHOPPING CENTER by a person or persons unknown. SERGEANT G.L. HILL was dispatched to the scene at 2:00 P.M. on August 31, 1963. He recovered this poster and received reports that several others had been placed in the area, but could find no witnesses to the act.

Another report was received from the DALLAS TIMES HERALD that a like poster had been placed on their building at HERALD SQUARE. There were no witnesses to this act.

The FEDERAL BUREAU OF INVESTIGATION has the following information regarding the SUBJECT organization. This information was obtained from a copy of the DALLAS MORNING NEWS dated November 12, 1961 and was a syndicated story from the NEW YORK TIMES NEWS SERVICE:

The SUBJECT organization claims to be an anti-communist group composed of 25,000 members. The reported head of the SUBJECT organization is ROBERT B. DePUGH of NORBORN, MISSOURI. The SUBJECT organization claims to be training its members in GUERRILLA WARFARE and has held seminars in the following cities: NEWARK, NEW JERSEY; PHILADELPHIA, PENNSYLVANIA; COLUMBUS, OHIO; KANSAS CITY, MISSOURI; OMAHA, NEBRASKA; and SAN ANTONIO, TEXAS. SUBJECT organization claims to have a large amount of ammunition and arms in various parts of this country, but this has not been confirmed. The largest group of the SUBJECT organization is in SOUTHERN CALIFORNIA. There is no reports of any such organization in the DALLAS area.
