Dear Sir,
I thank you for your letter of 12/3/74
It was disappointing for me.
The Warren Commission exhibit 385
showing the trajectory of the magic

Here are the facts about the
S. E. affair. There are 2 distinct
parts.

1) In 1930-38 I was working as design
engineer in ~~the~~ World famous war plant
Edgar Brandt in Paris (France). In 1936 it
was nationalised as other aviation and war
industries. I put an add and was contacted
by a gestapo man who was posing as
representative of german industries. He
introduced me to DWM (Munich) and
Rheinmetall-Borsig (Düsseldorf). They made
phony contracts with me. After they
got from me all the information they
arrested me (in Stuttgart) and were ready
to torture me; plunging the head in a
water tank containing chemical - making
you sick. In Chile the military put up
by US ^(CIA) use experiments. In the last moment
they found on me the copy of a letter to
going protesting ~~the~~ motivations of
the gestapo upon me. I was jailed for
3 months and one week before the war
started (Sept. 1, 1939) was expelled to
Yugo-Slavia. Have a bit of documentation
on the above affair.

Dear Mr. Kotikov,

I'm sorry you think I'm a magician, that my letter disappointed you, and that you seem to regard the most elemental objection to the Warren Report as a great discovery. If you had read my books, my very earliest, you'd have known that what you say I did publish and much, much more.

However, I am but a single man. Rather than your insult of ~~bring~~ "bringing in money" I have gone deep into debt to do this work. I can't control the press or the FBI or the Congress or the courts. I do what I can and I believe it is more than the average man dares.

However, what would be wrong with my making money that is not as wrong with whatever you do? How else is one to live? How can one afford to do the work of which you are so ignorant and in which you are, despite your protestations, also not interested in anything new?

I have spent 11 years doing this. You appear to be entirely unaware that the suits you cite were subsidized. I filed four without subsidy, even acting as my own lawyer. There was not a penny to assist in this: from you or anyone else. I took one case to the Supreme Court. More than any other, from the Congressional debates, that one is the cause of the changes in the law.

Your insult is in this particular case in even worse ~~case~~ ^{taste}. My colleague in the book, who like me has given up regular income to fight these kinds of cases - without any help from people like you - borrowed the money to pay the printer. The rest of the considerable costs we have carried ourselves at some sacrifice. At 61, having lived all these painful years in debt, I could not.

However, if by some good fortune my books were to be profitable, can you see that they would make more work possible for me? I have other books of sensational disclosures read to print and can't. I could travel and do more investigating. I would not buy a Cadillac to replace my simplex car that survives for all its 120,000 miles.

I think you should examine into your own mind. Here you are reading me a lecture in a field to open and to work in which I have given up just about everything people want in life, have gone into debt, have run what others regard as some risk, and you talk to me about what is baby stuff in this field yet when you know there is a new work with new information and new information on the corruption, especially of the intelligence agencies and the price is cheap you have no interest? Then you presume to tell me what is and is not important based on painful experiences of your own past? "That Oswald ~~is~~ was a federal agent is not important." Well, this is hardly the sensation of the book and it is also hardly true. And the Commission did not investigate that, either.

I cannot begin to undertake any other work. I will continue to do what I can with this subject to which I have devoted at least an average of 18 hours a day for 11 years. If at some time I encounter a writer who might be interested in your story I'll refer him to you or, if you'd prefer, you can let me have on file what you might want for such an occasion. Several years ago I did give such a story about a Hungarian woman to another writer. Such tragedies, unfortunately, were not uncommon.

However, if by some chance you think it is because I am afraid, take a good look at this flyer on the new book. I live under surveillance. My mail is interfered with. When I travel my room is searched. People have been fired for just being seen with me socially. Except in war and in some countries they don't stick the head in a bucket of shit. They just bleed you.
