Dear Ms. Lake,

It was a remarkable coincidence that yesterday when we had a pleasant visit from a pair of high-school history teachers from three states away that one asked if I'd gotten any reaction to his putting something about me on the Internet a short while ago. I'd not that I recalled and then the mail came with your letter mailed 3/25.

As best we can determine until I make the packages, the prices on the books will be, the first of the Whitewash series and Oswald in New Orleans, \$27 each. Each is a xerox edition, the only way we can keep them available, each is guaranteed and we have had not a single complaint after several years. (I'll be 44 day after tomorrow, my wife will be a year older ten days after that, the reason for the visit referred to above, and we do have a few limitations. As you can see in my typing. These extend to using stairs so we cannot stock a printed supply which, at our ages, would be a considerable risk in addition. Friends come and bring up from the basement what remains of the original printings.)

Whitewash II and Whitewash IV are each \$13.50.

Photographic Whitewash is \$15.50. Post mortem is \$20.00. Frame-Up, on the King case, is \$22.00.

I'm glad you refer to "American dollars" because we are out in the country and if remittance is not in US dollars two additional banks each with an added charge are involved.

I'm glad also that you reflect an awareness of "disinformation" in much of the writing supposedly on the assassination. There are few books and their authors of which this is not true. Most of those writing in the field consider themselves Sherlock Holmes reincarnated but most are subject-matter ignoramuses who make up what they write about or distort the basis of it to conform with their preconceptions. True of both sides, both extremes.

I did not publish Case Open or what you do not mention, NEVER AGAIN! Carroll & Graf/Richard ^{or} Allen did. Publishers West is the major distributor. If your local stores cannot get them let me know and with your order I'll tell you how you can get them by mail.

With regard to your desire that I continue my work, I assure you, dear lady, that even when I was suffering congestive heart failure I did that. I've been on borrowed time for two decades or more so I've no fear of what we all

to come to sooner or later. However, there is no prospect of commercial publication, other than for awful stuff or what supports the official mythology. So, I'm doing rough drafts of books. One, greivable Topsy and is too long. It must be at least a half dozen books in it. There are at least another ten in manuscript form, as a record for history. While they cannot be published commercially (and you'll see the butchery in Case 001 and HEWER AGAIN!) they do and they will exist at several colleges and universities.

as I can get each retyped, without any editing, because of my health and years, I distribute duplicates of the disks to those scholars who, on getting them printed out, can also evaluate and make corrections.

I have been rushing to get as much done as I can.

A year ago last month I was hospitalized locally for, among many things, congestive heart failure and renal failure. Almost a ^{quart} of fluid was taken from my chest surgically. When the same thing happened two months later I was rushed to the Johns Hopkins hospital (he was a fine Englishman who started it more than a century ago) in Baltimore. Before going to the local hospital, a country installation with no doctors on staff other than in the emergency room, I wrote a chapter of a book until I knew the specialists would be awake and then went there. The next day I read and corrected it and the day after that I was in an ambulance to Baltimore, ^{where} Johns Hopkins is.

I'm truly sorry that for some years it has not been physically possible for us to continue to publish but I've done the best I can to make a record that will in time be available to scholars.

All my records, all my work, will be a permanent public archive at a fine small local college still mostly a woman's college. Hood College.

And there will be the duplications of the manuscripts indicated above.


