P.S. Please forgive my use of red ink hereafter, & on my check, & also green ink, as
my Ballpoint writing block is as defective as the nestivities of Congress and the
Warren Commission commissioners. The F.T.C. files & experience of millions of taxpayers
(including the pickpocket Senators & Representatives) prove millions of defective ball point pens
(deliberately manufactured to wear out too soon so the "lawmakers" could sell Congress to the highest
bidders).

After hastily glancing thru your book, I submit you gives the following aspects
in the JFK assassination:

Whenever ANY crime is committed, the suspects include ALL who profited the most
from the crime. That elementary rule of detectives and police is even more important in all
cases involving larger sums of stolen money &/or other reasons of state or ambitions.
When L.B.J. nominated Carl Warren to head the Commission, Warren used D.U.T.T.E.S
as chief justice, NOT to accept, because it was UNETHICAL for any judge to act as
investigator of any felony; & since the case forensically would be filed on the
calendar of the Supreme Court of the United States, Warren would become self interested
in the appeals &/or certiorari &/or other court proceedings records, motions, briefs
etc., so that he would be obligated to disqualify himself as a sitting judge on matters
etc. For an experienced detective
in which he was chief investigator as chief commissioners, For an experienced detective
attorney in California to ignore such judicial ethics, violated the Canons of Judicial
Ethics promulgated by the American Bar Assn (which Warren pretends he follows
in all other cases). Warren disqualifies himself as a comm. of the Commission, was he not
the one who stood to gain the most from JFK's assassination?

Among those who stood to gain the most from the policies
were, are & will be the U.S. Senators and Representatives who opposed the policies
of JFK & his proposed bills; who opposed JFK the most; The Southern
Senators and Representatives who opposed JFK's orders sending U.S. Marshalls and
Deputy marshals into Alabama to force Governor Wallace and his Alabama
Nazis to stand aside while Alabama public schools were desegregated.

JFK's civil rights championships, especially his recommended bills, lobbying in Congress, and his friendships for many negro and white civil rights leaders. Leaders for civil rights enraged and embittered the white race supremacists' agents in all Southern States.

Because the Southern white Nazis were impelable in their unceasing hatreds against JFK (and his Greater U.S. Army General) for their attempts to reverse generations of customs in the South wherein whites disfranchised negroes and re-birthed Segregation rights, equal housing, equal public schools, equal jobs, and equal pay, and equal opportunities for advancements, and equal churches, etc., the mentally blind Southern racists also picked on the religion professed by JFK and his Greater U.S. Army Gen'l - the Holy Roman Catholic Church as a scapegoat for them craftily to use to inflame insatiable hatreds by the several Protestant churches in the Southern States into unmerited hatreds against the Holy Roman Catholic Church, its hierarchy, its arch-bishops and priests and nuns and the Pope in Rome.

Every law school in the U.S. has law fraternities. When I was at one such private law school in Atlanta, Ga., in 1943, I was initiated into a law school frat; at the initiation ceremony (ritualists), I was taught a secret handshake by my frat brothers (whereby the hands cuffing fingers intertwine in a manner that only that frat's brothers know), of my frat brothers told me I should always thereafter use that secret handshake with other frat brothers, and when I was so recognized (secretly by that handshake), my frat brothers assured me that whether I so shake hands in any legal or state or federal courts, or grand jury rooms, or in the Georgia Legislature, or in the U.S. Senate, or

in the U.S. House of Representatives, or any other place in the U.S. or abroad; that just as soon as I gather the correct hands-habes, my first brother judge or justice or grand jury or U.S. attorney, General or U.S. District Attorney or senator or representative or reporter for the newspapers or magazines or TV or radio by many news-reals et al. would immediately grant me, as a lawyer, "favors" I would never ever if I were not a first brother, of that most powerful frat. As Atlanta, Ga. has been the headquarters for the southern cabal since 1860, & before that, such unequal, discriminatory & preferential rulings in my favor, & in favor of whoever my clients would be thereafter, obviously such a secret advantage would give me, as a lawyer, a far stronger winning percentage as a lawyer than all other lawyers would get if they were not participants of that law frat. That is why the southern cabal feloniously & treasonably stole the U.S. presidency from Samuel Tilden in favor of Hayes. And that is how Earl Warren and all his co-conspirators and attorneys and investigators conducted their phony investigation of the JFK assassination - because they, as lawyers & as law schools graduate, KNEW & KNOW of such secret hands-habes & other secret, felonious, unithal conspiracies between lawyers & judges & prosecutors & defense counsel & grand juries, and by their silence in their final report, & in this partition whitewash record, the Warren Commission feloniously indicated twelve.

As Warren was so ungodly and so willing to compromise the Chief Justiceship of the Supreme Court of the United States by accepting illegally repeat of Chief Commissioners

investigating the JFK assassination (which Warren then based off only from the daily press, radio & TV), how come Warren wasn't equally interested in the Bobby Baker Grilles to a number of U.S. Senators & Representatives, & in Bobby Baker's close working relationship to Lyndon B. Johnson, when Johnson was a Texas Senator in Congress & Vice President of the U.S.?

If Oswald alone murdered JFK (which I don't believe), his felony was at worst, a petty misdemeanor in comparison to Bobby Baker's Grilles of Congress, as far as the injuries to the U.S. Government is concerned. How could LBJ be innocent of accepting part of the Grilles offer well beyond guilty of negligence in never using his influence U.S. Senator or U.S. Vice President to fire Baker, & to demand the U.S. Atty Gen obtain indictments of Baker and all his confederates, Bullock, Brinkley, perjurers, conspirators, etc.

So Warren was a HYPOCRITE in accepting an LBJ appointment to the Warren Commission if Warren was solicitous for U.S. justice.

Just as the Southern cabal stole and destroyed votes for Samuel Tilden for U.S. president just so did their 20th century successors to the Nazi mantle in the South conspire to assassinate JFK, & they also succeeded feloniously, treasonably (& secretly covered their trails of felonies, treason & conspiracy).

My aforementioned facts, theories, analyses & conclusions
are no less sound than your own in your published book
"WHITEWASH - the report on the Warren Report". The Independent
man article by Alex Campbell, in analyzing your book, states, in part:
"Weasberg, a former Senate investigator, attacks ~~Marine~~ war-like
a Marine with a machine gun. Some of his shots are wild,
but many of them inflict wounds, perhaps fatal...
The Warren Report may never have been able to credit and
require a full autopsy."

If my intellectual aforementioned shots are "wild", then they are no wilder
than yours own in your book, nor that of any other of the many
other authors of many other books and articles on the JFK assassination.
The New Republic and Alex Campbell are ignorant and stupid
in praising your book as an attack "war-like a Marine with a
machine gun", because that implies Marine machine guns are
efficient guns, whereas Congress conspired feloniously & treasonably
to order and pay for DEFECTIVE machine guns for the
Marines, and Army, and Coast Guard, and Air Corps, and
Navy, from the Pat machine gun fraudulent patent to The New Republic,
article by war-moron Alex Campbell.

On the TV program you were in the panel with People's Court,
that, not word informed millions of TV viewers of
precisely where TV viewers could buy a copy of your book,
or the books of the others in the panel, nor did TV state the
sales price per copy. As I have witnessed many other TV
programs (Mike Douglas - Variety, & other programs)
wherein other books (not on the JFK assassination) were

mentioned on those TV programs by authors on TV, and the ^{ALC.} ~~America~~
was sometimes broadcast, all such other TV-broadcasts
on many other types of books (not related to any crime)

Desecrated against your book, against FBI vs. My-Strich
by Penn Jones, Jr., & the other authors on your TV panel.

Finally, a note replying to your Nov. 19, 1966 letter to me,
in which you state, "I do understand its non-availability in
Manhattan bookstores - since all the largest distributors have it...".
I do understand its non-availability in Manhattan's largest bookstores
and in the Bookseller in Grand Central Terminal in Manhattan. It's
just as understandable as the non-availability to buyers of the
books and articles by the late Louis D'Amato Granello in his
years of exposures of the felonies, misdemeanors, stupidity,
ignorance and conspiracies of the Board of Directors and trustees
of the New York, New Haven & Hartford Railroad Company, as
puppets of the J.P. Morgan partners, Vanderbilt, et al.
That's why the J.P. Morgan & Co., Inc., and Manhattan's 17 largest
private investment bankers controlled the U.S. media to
inflame U.S. public opinion against Adolph Hitler and his Nazis;
cut threats by publishing in the U.S., bonfires by the Nazis
gangsters in the streets in Germany burning books that they
disapproved of because their authors criticized the Nazi way
criminals. Your book and Penn Jones, Jr. book make the media
in the U.S. 100% ignorant, stupid, mercenary, felonious and
