I've been very successful in getting the inmates motivated and participating in a variety in activities and I am pleased with the relative success. It is like banging my head against a wall. It feels so good when I stop. But there is encouragement occasionally.

Buck is a year old and is learning how to walk. Jan is doing a wonderful job with him and he says daddy a lot and seems to know something is missing. I look forward to being with him and her.

My foot has healed but not to my satisfaction. I have begun working out again and it is uphill, but with a little luck.... Kenia is that ever an understatement. Well anyway, I'm doing what I have wanted to for so long. It just may come together soon. I look forward to putting the past six years behind me for good and becoming the man I should always have been.

It is a long fought dream about to become  
a reality. But this... I can deal with.  
Can I ever! It has been tough though.

When I get out I'll bring Jen and Buck  
up to visit you both. Wish me luck and  
let me hear from you.

It is very good that you are able to remain where you are and do worthwhile things to help others. An important aspect is that in this you also help yourself and probably learn much that is worth knowing.

You may be getting through to some of the more obscure inmates without knowing it. What may not show now may be there and be of some value to them later. Hope so.

I was impressed with Jan as a fine mother when I saw her and Buck.

You say your foot is healed but I don't remember your telling me that you had hurt it. I hope not kicking a wall!

There isn't much news here and I rarely hear from any of those you know. Jill is the first in a year or more.
