THE WARREN COMMISSION was created to answer certain crucial questions about the Kennedy assassination and Lee Harvey Oswald. In spite of the volume of material presented before the Commission, many of these questions still remain unanswered. Mark Lane asks why. Step-by-step, he examines not only the evidence brought to light by the Warren Commission, but the explosive evidence to which it gave only cursory attention. Lane offers no "assassination theory." He does expose serious and irretrievable inconsistencies in the work of the Warren Commission, as highly as these inconsistencies are small, some are frightfully large; combined, they raise insurmountable doubts about the "official version" of the assassination of John F. Kennedy.

Kennedy.

Mark Lane has practiced criminal law in New York for more than 20 years. In 1968, Mr. Lane, together with Mr. E. J. Conroy, Senator Herbert Goldhamer, and others, founded the Reform Democratic Movement within the New York Democratic Party. Following the Kennedy assassination, Mr. Lane formed the Citizens' Committee of Inquiry and began an investigation into the facts surrounding the assassination and the murder of Lee Harvey Oswald. He personally traveled to Paris, Berlin, London, and other cities to interview witnesses, and has lectured widely throughout the United States and Europe.
