He has spoken to Gonzalez and Dodd. They had planned for closed sessions on Gonzalez' motion but Dodd and others made long speeches on everything in public. Dodd told Me they have enough to break the King case now. So Dodd changed his formulation to that it might be possible. He began certain. They think that people connected with the government were connected with the crime, he says.

Sprague said we can break the King case because the man who did it is still alive. They dismissed the window sill as being of no importance. (Me laughed.)

He says that Sprague is going to present murder cases to the committee and that it thinks it is going to be in a movie with the script.

He says Lane is running the committee and that Gonzalez is his source. Lane is doing this through Sprague, Gonzalez says. (Ozer was uptight, openly hostile when I warned them about Lane and his improvisations on the very, so much so that after he left Donovan Gay felt called upon to apologize for him saying he was only being devil's advocate.)

In general Me thinks they are crazy and going to fail as they are going, as I gather. He did not say this. He did say they should hire me and I explained why I disqualified myself in advance. He said that Gonzalez told the Rules committee they were going to use me somehow.

He did not tell me but he was in Washington. I phoned back to tell him I think he should be assigned to that story because he is the only reporter who will do the right kind of honest job. We discussed more. He is to call me back after lunch.
