Lone on Jersy williams Show, \*\*\* W.CA, MYO, 3/24/77, supposedly on Lifton-Jeff Cohen article in New Times, with them, Robert Sam Anson and Jerry Tay.

While this shed nos light on the kin assassination and none of the participants reflected any knowledge of it or any real investigation of it, have succeeded in monopolizing much of it and keeping it of the alleged subject, that article. In this neither truth nor fact impeded him.

Early he claimed that his COI was established to get congress to investigate the hing assassination. The fact is it was not and the reason he was not is because he would not getimto the aing assassination.

he says he is Jerry's lawyer for purposes of suing over the article and if he does not say he is Jimmy's he implies it strongly.

Says he "urged" Jimmy to testify before the House consistee and that he erranged for it. "One of the main problems was that Ray was represented by Lesar " who had done

everything in his power to keep Ray from ever being heard publicly." Claims Lesar did not represent May well "because he has 99 years." & over not talking to the committee.

"No one has ever heard Ray's story."

In saying that he had not heard from Jim y for 3 1/2 months prior to the wing assassination Jerry here says that Jim y phoned him from a bar in not Arizona but Texas.

At the end of the first side Lane says the case against Ray is falling apart from what he has already represented as his work.

Toward the end hane is self-trapped by boasting that he knows what the house committee thinks about the Lifton/Cohen New Times piece. (Lifton has already spoken of the time he spent withthe committee). Lifton prods hane who then lays it out, how he is in touch with the committee on "almost a daily basis, and they've come to me for a great deal of material on" the King assassination.

he also says the book"is based on our investigation, Dick Gregory's and mine."

Lane on WEAT-Lynn Samuels, 5/18/77

At about 30 or just before it on side one Lane talks about Lonnie Hudkins, not mentioed by name, and about Lardner as part of "cabal" to destroy the House committee. Burnham same sense. about 40, reporters "acted in concert" in interest of or at behest of intelligence agencies..

50: Murtagh had two of his own informers inside Atlanta HQ of SCLC.

57 FBI'd "withdrawn all surveillance moments before Dr. King was murdered." Aing had FBI and Hoover in mind in his "mountaintop" speech. (60)

Lane calims he has done "much" of what he calls "investigative" work in King assassination. ing did not opme out against VN war until 4/4/67, noting this is exactly year before assassination. Actually it was years earlier.

On side 2 he sayd he "never speculated about anything in the Kennedy case." Stutters some in repetition of this biggest of lies. He then goes on to say with king he does and this leads Hoover and the FoI as "prime suspects" in the killing.

Holloman personally "stripped away the black witnesses." This is false as it relates to Holloman, false as it relates to witnesses and false as it relates to black witnesses and false as it relates to balcks then inside the firehouse. Lane-Ruie on Stanley Siegsl Show 5/9/77:(cassette says ABOTO but it is WOR-TV)

Lane: King "had reservations at the Holiday Inn, the Rivermont," but/#46/16/64/ Hoover's stories drove him from there.

3/28 violence "by an agent provocateur of the FBI." (20)

20+ the only time "ing was not bugged by the FMI was just before he was killed. Holloman personally withdrew Reddit "moments" before the assassination.

404 claims to have been the source of the fact that had the House committee established and its source since then, evasively. Explains as though! it were all original and unpublished while not stating this that he went to Memphis in August of 1976 with Abby Hann. Claim to what he did then was speak to Redditt, Mewsum and Wallace and then Murtagh.

Repeats there was no government investigation until after tye cities were aflame, here saying 60 of them, and that Atlanta was put in charge of investigation and it out the "get King squad" in charge. Furtagh was its relief supervisor. Repeats "to this day" there was neother government investigation except that under the squad assigned to destroy him. 50-
