if there are any interviews I hope they are not as hurtful as those for which I had no responsibility have all been. It is not true that Jimmy has had no publicity. It is true that I had to fight him to get him to agree to quite a bit, all good.

You say the House ascessins will have Rosenson in jail. Didn't I tell you that they leaked a story that he is in a Virginia jail and called Jimmy a liar? Thought I did tell you. It was on Washington TV.

You now says you know nothing about the earlier story involving him. I remember Xman 1973 very well and some first-rate checking by two of the best reporters, as well as some really silly court papers filed them. That was arab stuff and you should remember it.

There is a problem about that card besides the fact that there was no LEAA then. It is that I have had a chance to read the official lost of the property taken from Jimmy when he was arrested in England or when it was turned ever to the PBI, I've forgotten which. It was a while back. In any event, there is no such eard on it. Several scrape from newspaper classified ads are. I remember this kind of small stuff was included then.
