Your 2/27 did not come until today. You said you would mail it the next day. It took rather long if my 2/22 did not reach you until 2/27.

Because you say you are going to Enexville over the weekend I may delay mailing this to see if I hear more about you becoming John Barrymore in addition to F. Lee Bailey.

Is therenothing about that that isn't crasy? I've been telling you what I've been learning from the FBI that I think you should know. I have no interest in your personal life. But they did and I'm trying to put evidence together. There is no telling what there could be that relates to Jimmy's or John's cases. I thought I told you this and that a separate request will take a year before they get to it.

Now I want to tell you again that I have never held anything on you that you said you wanted back. There are several things of the past you said you did not want and because of that and what has happened to me I can't find them. If and when I do you will get them. But I sent what you sent me in "riday's mail of last week. I get Jim to make copies for himself and I put whatever you gave me and mailed it te next morning. That was the 26th. You should have had it early this week at the latest. If there is more late sail then it would seem there is some interest in it.

I did not know that Kane got in touch with you by sending a couple of young girls to Richard Hyan's office. I had just though it was through Jimmy. I wonder why he didn't when he was in touch with Jimmy.

Funny how you got reports on my book when there were none to be had. I did not even have an agent. The one thing that happened is that somebody referred me to an agent. He did nothing and I've done nothing. I may soon. But the truth is that I have not done any writing on it since April because i have been doing ether work. So I'm interested in who is making things up to feed You. The one thing I can think of of course is henc. We never speak and because I'd done no writing I'm wondering why somebody is making this kind of stuff up. Probably to con Jimmy.

Glad Stoner thinks I did Jimmy a lot of good. But you can t be as stupid as you talk. I have no interest in you for any book. The only reason for the files is the one I gave you. I've had all of this nonemase I want. If you enage your mind and want me to get them I won't. I really do not believe they are essential in Jimmy's interest but they could be in John's and you also would know what they were doing about you.

So don't believe what I've told you about Lane. You'll find out. He is sick in the head, bright, crocked and can't tell the truth when it would help him. The only people who think well of them are those who do not know him except from his own baloney about k himself as he sheaks.

I's have sent a letter to limay if I'd known in time. I have sent him much lately in an effort to inform him but I fear it is a waste of time and that because he does not want to believe what is real hr'll explain it all away to himself by getting angry. I forgot to tell him that most of the hearings of the kind you and he talk about are behind clo sed door and they let out the parts they want out, not wan what you want, as is true of the questions. In almost six months this committee has held no real hearing and no public hearing except for a small part of one. The call them executive sessions.

Ix guess on the 28th you had not gotten what I returned. You keep talking about exhibits. I don't know what was in those papers but I sent all I got back. I remember having seen something from Haile as I refolded the papers to go into the envelope. And Jim has a copy.

No, the files on you are not freely available. Some not on you but where you were interviewed in a case, things like that, are. But whatI'm talking about is a different

kind of file. They make me believe that there could be in files on you what could be of value. I couldn't care less for myself.

Each time I hear from you you are puffing yourself up more, psyching yourself up to believe you are what you are not and that you can do what you cannot and that you understand what you do not. I'm sorry bout this. You'll have to put your own ass in a sling before you realize - when it is too late. I'm telling you that there are plenty of indication that they are now out for you and Jimsy through you. If you understood the Department of Justice report at all, and it is in plain English, they said the FEI did an honest thorough job - except on YOU. They were criticised from to doing anything about YOU. Under these circumstances the last thing you want to do is testify to anything under oath where it can be used against you, probably by twisting.
