Lane: His 5/3/77 press conference.

If Lane did npt have all his remarks written out he had them in detailed notes. After the press conference several reporters went up to check some of it, I think about the Ray film he presented.

George told me afterward that the film was made on 4/24 or the week before hanc used it to promote his book. There is no use of it possible in Ray(s interest and there was nothing new in it in any event.

This is to say where it was either real of fairly accurate.

Oscar Collier came up to me. He was the editor on the book. I needled him about what he had told me when he was president of Twentieth Contury Publishing in New York. He had been Line's agent and "arguerite Oswald's. He then told me that Lane is a bastard, that he had gotten "ane an advance from "arney Rosset of "rove Press for a book not on the Commission but to appear before the Commission issued its report. The advance was not large- \$1500-\$1800. Lane mover delivered that book and refused to give the advance back.

Yesterday Oscar claimed that there had been no such deal. When I was specific he said of, that was "Rush to Judgement." It hap ens that Rush to Judgement is supposedly on the "eport, not the book contracted. The appears to have been Lane's editor, from what he said and this is not unequivocal—since Chicago Eyewitness.

We got into the dirty businessof the book and I said I might have to take time to do something about it. Oscar said simply "You can't." The manner of this was that they were aware from my having put P-H on notice—he indicated awareness of this — and had deliberately come as close as they could to what they consider actionable but had sought to make what should be actionable not actionable.

It was vintage Lane: "I have never for one moment speculated" on who killed JFK.
