ARTICLES OF INCORPORATION
OF
CITIZENS COMMISSION OF INQUIRY, INC.

To: The Recorder of Deeds, D.C.
Washington, D.C.

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation adopt the following Articles of Incorporation for such corporation pursuant to the District of Columbia Non-profit Corporation Act:

FIRST: The name of the corporation is: Citizens Commission of Inquiry, Inc.

SECOND: The period of duration shall be perpetual.

THIRD: The purposes for which this corporation is organized are:

1) to research and analyze the material relating to the assassination of President John F. Kennedy and the Warren Commission.

2) to educate the American public as to the facts of this assassination and the investigation of these facts by the Warren Commission and other federal organizations. This is to be accomplished through lectures, radio, television, written materials and other media coverage.

3) to do all things necessary and proper to carry out the foregoing purposes.

4) this corporation shall not engage in any act prohibited to a corporation exempt from tax under Section 501 (c) (4) of the Internal Revenue Code of 1954 or any successor provision. In particular the net earnings of the corporation shall not inure the benefit of any private shareholder, the corporation shall not be operated for a profit and the corporation shall not engage in any political campaign in any manner whatsoever.

FOURTH: This corporation shall not have members.

FIFTH: The internal affairs of the corporation shall be regulated by the board of directors as provided in the by-laws. The number and manner of selection of the board of directors shall be specified in the by-laws.

SIXTH: In the event of dissolution of the corporation, the assets, after paying all legal debts, shall be distributed to an organization selected by the board of directors whose purposes are consistent with the corporation and which is exempt from tax pursuant to Sections 501 (c) (3) or 501 (c) (4) of the Internal Revenue Code of 1954 or the comparable provision of any subsequent revenue code.

SEVENTH: The address, including street and number, of its initial registered office is 103 2nd Street, N.E., Washington, D.C. 20002 and the name of its initial registered agent at such address is Mark Lane.

EIGHTH: The number of directors constituting the initial board of directors is three and the names and addresses, including street and number of the persons who are to serve as the initial directors until the first annual meeting or until their successors be elected and qualified are:
