# Judge Now Dead But Plea Is Filed

SALT LAKE CITY — Every story must have its ending. And so it was that despite the death here last Saturday of U.S. District Judge Willis W. Ritter, his attorney went ahead Wednesday with an effort to clear the old man's name.

In a poignant move, the attorney, Daniel L. Bernstein, filed with a federal appeals court in Denver a brief in support of Judge Ritter's motion to dismiss an unprecedented effort by the Justice Department to strip him of his judicial power.

The irascible Ritter, the nation's oldest and most controversial chief federal judge, had been accused by the local U.S. attorney of repeated misconduct on the bench, hostility to government lawyers, mismanagement of his court calendar and behaving erratically.

In summary, Justice Department attorneys said the judge had become "a law unto himself" and had asked the appeals court to disqualify him from hearing any cases involving the government.

# 2 Congressmen Join Protest of Seal Hunt

SAN FRANCISCO (AP) — For the third consecutive year, a party of environmental activists headed by the Sea Shepherd Foundation is headed for the Bering Sea during their annual campaign to hunt harp seals.

Ready to join 28 members of the Greenpeace Foundation on the excursion Thursday for the first time were Rep. Leo Ryan, D-Calif., and Rep. James J. Jeffords, R-Vermont.

Both congressmen have sided with environmentalists in past battles. They have indicated they are joining the Greenpeace mission to raise international ire about the seal hunt.

"Congressman Ryan feels the people in Canada are quite properly in they had a right to speak up about Vietnam," Jeffords said.
