California black minister who married James Earl Ray and Anna Sandhu Ray said today he was told the FBI was involved in the assassination of Dr. 4 Martin Luther King.

Rev. James Lawson, pastor of the Holman United Methodist Church, Los Angeles, also confirmed that he will sign an affidavit to be used by lawyer Mark Lane in his efforts to obtain a new trial for Ray.

He said in a telephone interview from Los Angeles the affidavit is on his desk but he has not yet signed it, but that he

Mr. Lawson said Rev. Joseph Lowery, president of the Southern Christian Leadership Conference, told him of a conversation that Mr. Lowery had with Rep. Walter Fauntroy, chairman of the House Assassasination subcommittee investigating the slaying of Dr. King

He said Mr. Lowery told him that Mr. Fauntroy told him in early December 1977 "that the FBI killed Dr. King."

"Fauntroy did not say, 'I believe it."

He said Mr. Fauntroy did not give Mr. Lowery details of the evidence. This apparently is contrary to what Mr. Lowery is saying now. Wire service reports yesterday quoted him as saying Rep. Fauntroy never told him FBI agents answering to J. Edgar Hoover, late FBI director, killed Dr. King, 8001998 B 901994

Mr. Lawson also said he had talked with Brady Tyson, an aide to Andrew Young, U. S. ambassador to the United Nations, about information Mr. Tyson'allegedly gave Daniel Elisberg about the King assassination. dell oza neo crist in

Mr. Lawson said Mr. Tyson did not give him the same information but merely confirmed that he had given the information to Mr. Ellsberg. Mr. Lawson said he called Mr. Tyson to confirm that he had given information to Mr. Ellsberg.

He said Mr. Tyson told him that Mr. Ellsberg was "a very honest men man of integrity," apparently supporting details of the Ellsberg affidavit.

Mr. Lawson said he thinks the Ellsberg affidavit is "very clear." He said Mr. Ellsberg is not the kind of gily to confuse theory with fact."

"It's not Mark Lane's suppression, it's not the black community's suppression. It's government agency it people in public life who are suppressing it."

He said he assumes the motive for the

"suppression" is that "they know James Earl Ray did not kill Dr. King and they don't want to let out the information."
