Dear Lasse,

If I did not thank you for the beautiful job you did on the translation and as I recall the attractive dictionary, my sincere apologies! It was very attractive, and we had it on display here for a while, but lacking shelf space and none where it would be visible we then gave it to Hood College, then, rather, because they do put such things on display in their marvelous new library building and because students could use or see them there. Eventually all I have will be there in any event, permanently, a permanent public archive. Many thousands of pages are there already, along with a number of objects that I've already given, like replicas of the rifle and of Zapruder's camera. <sup>films, etc.</sup> My limitations, including on mobility and the use of stairs, deny me access to most of my records, which are in the basement, and aside from problems in using the file cabinets in my office, they are overfilled and I've used up all the space atop them for boxes that hold manuscripts and records. So it was also to protect them that I gave them to Hood, which was pleased to get them.

I must have assumed that you are a patron on The East Hurrah Bookstore and that they'd let you know they would have NEW! AGAIN! Friends from as far separated as England and New Zealand placed orders in advance and had copies airmailed. If you do not know them, Andy and Linda, the man-widow couple, are fine people and friends. They are at 957 Memorial Ave., Williamsport, PA 17701. By error the index was omitted in printing. I gave them a copy and they can supply it at the same time. It was never corrected or edited and an economist friend told me that he found at the beginning it was a page off and that later it was two pages off. On my one use of it I found those two pages past the point referred to.

Roger Feinman filed that suit for Groden. I provided a lengthy affidavit in it that was not refuted. But they lost and the case is on appeal. Feinman has not yet sent me the appeals brief or its appendix. I am sure it is of documentation against Posner. I doubt it would help you on your translation but I'll enclose a bit that you might want to use. Both are from the Anchor, which is owned by Doubleday, paperback reprint. One is

how little he could say about me and was not able to refute a single thing I said and the other is how less than honestly he finally had to admit cribbing from Failure Analysis. What he writes about me finally getting commercial publication proves all over again what I said about him, that he has trouble telling the truth even by accident. That was as best I can now count, not my first commercial publication but my 13th.

I fear that the Assassination Records Review Board is going to do very little but it is making a record that will enable it to say it listened to everyone. They did give the nuts enormous opportunities to dump all sorts of irrationalities on them but

they ~~do~~ have to not steadfastly ~~or~~ refused to make any real effort to get any of the many significant records that can embarrass the agencies. From what I asked of them this ranges from the notes of the autopsy to what the government did to and about critics and what they wrote. The CIA records that have been disclosed were not disclosed under that new law. They were disclosed under a historical-records program in advance of the law that the CIA knew was coming so they could withhold what they could not withhold under the new law. and the board has not made them reprocess <sup>that</sup> ~~the~~ quarter of a million or more pages.

By the way, the "human book" on these records is terribly bad, dishonest, misleading and even ignorant. Waste of time and money for you. It was a great disappointment to me because based on his Viet Nam book I'd expected a fine work like it.

It is fine that your grandson could make the school presentation on the JFK assassination he did. It should have given him a feeling of accomplishment and that is good for young people to have and to feel and to remember.

We are both about as well as we can be. Both have a bit of trouble in moving around, I had to use a cane most of the time, my wife once in a while. But between us we have done well to accumulate 165 ~~years~~ years.

Feel free to correct the errors + picked up in Case Open that the publisher did not pick up.

Dear Harold.

As it is long time now since I have been writing to you, I have some few questions to ask you, if you got the time to answer. First of all. How is the publishing of your book "Never Again" progressing, is it still delayed from the publisher, or is it now on the market, as I intend to buy copy.

I have for some time now been working on a translation of your book "Case Open", and in that connection I notice in the last letter from Jim Lesar from AARC, in a list of items of special interest from this organisation, two items in connection with Posner's book "Case Closed", Robert Groden v. Random House and Appendix to Appeal Brief in Groden v. Posner.

I was not aware of those proceedings in the U.S. District Court, and wonder whether it will be a help for me in the work with your book, to obtain this items from AARC.

I would also like to ask you whether the new Assassination Materials Disclosure Act of 1992 have lead to any new documents of interest for you, or it is just another attempt to deceive the american public.


Maybe it will interest you that my grandchild, who is 13 years of age, for some time have been working on a project to present in his school, the subject was President Kennedy his life and the assassination of him.

In that connection I was lucky to been able to supply him with some advise and more important, some material from your books. The project was well received in his class, and have now lead to many debates among his teachers and fellow classmates. It shows, that even in Denmark among the young generation, there is also a great interest in President Kennedy, his life and the events that lead to the assassination.
