Dear both,

If I did not send it to you earlier I enclose the NEVER AGAIN! page of the C & G catalogue.

Last year I gathered up all my reels of assassination film and slides and gave them to Hood College. I enclose a list and would appreciate your giving me as best you can an appraisal of their value for 'til to use for tax credit.

John Martin was a college boy travelling on vacation when he just happened to be in New Orleans where Oswald was arrested. This reel shows him including in angles not in any stills and the Cubans who picked the fight with him and the leaflets they scattered.

I have no recollection of the Super8 of Oswald in New Orleans. I presume it is either what film there was of him in New Orleans gathered and added together or what was prepared for use in promoting the book, pictures, documents, etc. If you would give different appraisals I suggest you give the lower one to be honest, or for us to be.

Ilya Kamentov was one of the Dallas area White Russian community. I presume this interview of him is on what he knew about the Oswalds.

The Oswald ~~filming~~ footage from the Dallas FBI files must be what it could get of the TV footage.

of the CBS Channel 2 footage all I know is that it is related to the assassination and ~~is~~ is from the Dallas main assassination file. I presume that it is a reel of assassination footage, TV news film.
