

Lattimer-KHJ 1/24/72, Art Kevin

In describing rear neck wound he never mentions scorching. On the front wound, "no longer visible as such".

Two bullet holes in front of shirt and this is where bullet came out.

Only evidence not other direction is inclination. Describes "true location" as "very low in the neck." So he can't "reason" I went front to back.

How does this stuff assure LHO is lone assassin. Switches to experiments "I have done at some length". Describes them as "merely observations of fact". When you get to who fired the rifles, you have to get the data provided by the Warren Commission, which he accepts without question, this he validates no more than what he had never questioned. "Nobody has challenged in fact", then "not even the most vigorous critics" challenge the basic story.

Doesn't know of parafin test which shows no handling of rifle. Handprints on gun proof.

Front neck wound - showed that it applied to him in front. "his hole hole" - several things showed that it happened with front, air, prop + in L.M.C.

"Does it irrefutably prove that it is the only way" - back to front. Answer by indication of "his track". He found wound much longer than he had indicated.
