Dear Harold,

I am attaching a letter I have sent Paul Hoch , re any Guinn notes he made.

This weekend, I am getting back a superior tape recorder, from repair, and will do my best at getting you at least one additional page of transcript. The page I sent you is the only one I made.

Here is a piece of information you may find useful. Checking with a friend who should know, I have been told that one way to see whether or not the little slivers inthe sample box are in fact authentic fragments, or were scraped off with a tool of some kind, is to photograph them either with an electron microscope, or with a good quality ordinary microscope. I am told that if the flakes were physically removed by scraping——no matter what the tool——a micro—; hotograph would easily reveal that fact. To be specific, it would show the tool marks on the flake just as a rifle barrel engraves the stria on the surface of a bullet. And that a flake dislodged during a collission would break along lines determi ed by crystal structure——easily distinguishable from a flake taken off with a tool.

My friend has promised to send my some literature relating to this; and I have beenk considering writing a memo to the HSCA---not that it will do much good.

But taking a picture of somethic through a microscope is the s mplest kind of non-destructive test, and it just might develop evidence of what we suspect--that the fragments are fake.

Again, I'll try and do a bit more onthat tape this weekend.
