The transcript of the police broadcasts to which I referred you is CE 1974. It is in 23 and 1:47 p.m. is on p. 874.

On those things you mention with which I do not agree I also can't be of any help.

On the missing MDW records, I have a dim recollection of someone looking in my file under MDW and recalling later that I never filed it there but had it in the Lifton files. I expected it to be there.

I think you know there are other things I want to use my little time for and when I'm with others or helping them I can't.

Once when you were here I think with Rick I showed you the file and told you to copy whatever you wanted. It then was in the Lifton files. In the MDW's envelope.

Once before that someone did make a copy of it but I don't recall now who.

I can't and I don't make any accusation against Rick but he is the last person I remember who was in those file cabinets. David had no interest. He went through other files, DJ's. and for quite some time I recall nobody else who had any interest in that or in Lifton.

With some luck, I should have some money by the end of the year and present you with a new, trouble free Cannon Copier -

Yarborough's short affidavit in WCH 439-40 has nothing at all about a knocked down SA or FBI agent at Parkland, as you mentioned.

Judy Bourner's transcripts (DPD) end at 1:56 (Chanel 1) and much earlier on Chanel 2. I find nothing whatsoever on removal of the body.

Please give me a lead on where the complete transcript is published in WCH + E - There is nothing in the Exhibits - Price? Graves? Leaville? (I know those can't be right but maybe will jog your memory.)

Funeral directors are often real crooked. Since the U.S. actually paid \$13,495 for the Britannia, \$10,000 was added on, as the price was \$3,495, BUT perhaps the casket actually sent by O'Neal was a cheap "bronz colored plastic" casket, as Kemp Clark wrote: "Plain," others

at Parkland called it.

We may have a colossal semantic problem here on some issues.

I still have to solve the "surgery to the top of the skull" (Sprecht + O'Neil), which seems to be corroborated by statements (external) to me by Jenkins of an incised brain stem, 2) a deep slice into the brain, 2-3 cuts along fracture & suture lines to enlarge the large defect.

They claimed that the brain fell out into Humes hands.

It seems to me that its prima facie that the photo of the Rt. side of the head (lateral) is a painting, according to Humes placement of the large defect. The back of the head pic is problematical. Hifton seems to use "laceration" to imply "incised." I don't think he knows what laceration means (to tear or mangle).

I'm tired of being everybody's target. Did you know the MDW file was incised before I drove out there in that dangerous storm? Do you know what Rick is really up to? I think there are a lot of hoaxes here, there are a lot of bad people in this "critical community" and they made me the target.

P.S. I've been ill ever since I saw you.
