Dear Mr. McGreechin,

I'm sorry if my earlier letter did not make it clear, but much as I'd like to it is simply impossible for me to update all the people who write me about my work or ask me about what I've already made available, to the extent possible, in the books I've published.

There is and for years has been considerable interest in the political assassinations and many people do write me. But as I think you can understand, nobody conducting detailed research and hoping to complete books can begin to respond to such requests and still have time for anything else.

In my case this is a more acute problem because I'm 72 years old, have serious and severely limiting illnesses, and must spend an appreciable part of each day in therapy.

I am aware that you have a genuine interest, but I hope you will understand that ~~my~~ engaging in the kind of correspondence you want is just not possible for me.

If and when I publish an eighth book, which I do hope to be able to do, we will let you know.
