Section Chief WILLIAM BRANNIGAN telephonically advised 11:53 AM this date that the Bureau had sent a XeroX copy of a letter from CIA, captioned Assassination of President JOHN F. KENNEDY. This was sent by routing slip. He referred to paragraph 5 regarding some evident scars, etc. on the hands and wrists of OSWALD and the possibility of requesting exhumation of OSWALD.

Mr. BRANNIGAN advised that no action should be taken along this line without Bureau advice and instructions.

Mr. BRANNIGAN referred to Dallas teletype dated 2/20/64 regarding the interview with THORNE, and requesting clarification as to MARTIN's refusal for interview.

Mr. BRANNIGAN was advised that during interview of THORNE, as set out in teletype, he stated he would advise MARTIN, his client, not to furnish information to the FBI. By way of clarification, Mr. BRANNIGAN was advised that at the time of the THORNE interview, THORNE telephonically contacted MARTIN and so instructed him, and at that time MARTIN advised the Agents that on advice of his attorneys, he would furnish no information concerning his association or activities with MARINA OSWALD.

Mr. BRANNIGAN advised that this clarification would be put in a memorandum at SOG and no further action need be taken by Dallas.

Mr. WILLIAM BRANNIGAN, Bureau Headquarters, called at 8:50 AM today regarding the interview of MARINA OSWALD.

I advised Mr. BRANNIGAN that Attorney MCKENZIE arrived back in Dallas late Saturday, but that he would not permit us to interview MARINA until 1:30 PM today, that one of the children was sick, etc.; also, that MCKENZIE desired to sit in on this interview, and it was expected that it would take at least a couple of hours to complete the interview today.

Mr. BRANNIGAN requested that the results of interview be telephonically furnished to Bureau as soon as completed; that they be dictated to a stenographer in Washington so that a memorandum could be prepared there for the Director. A teletype regarding the interview should also be submitted.
