The TT concludes by stating that "Phayinal Surveillance was discontinued at 10 e.m." that acroing "Informat coverage continuing." I recall no earlier reflections of informat coverage. I'd be inclined to believe it would have to have been by sensone or sore than one in her trust. In those days after she was separateifres both fairs I'm inclined to believe this would almost have to be a member of the White Sussian community.

I believe she was then staying with Declan and Katya Ford.

While it does not so state this appears to be a chronelogical reporting on what happened on "arina's phone.

The first is that her new lawyer, William &. Hedensie, "centacted her." Next that "News. Ford contacted arise," in a context indicating it was not News. Ford's home.

Sent Marina contented Ars. Ford to report the unseccessful efforts of two reporters to get to see "arina. It is in this part of the reporting that there is gross and so far as the case is concerned pointless violation of "arina's rights to privacy: "Marina said she saw "artin in her dresse last night and asked "rs. Ford to check on sedication to help control sexual desire. The said if Martin had not been storelized she would never have been intimate with him." After a little sore of this there is her wonder if deschronschildt "was a normal person. Ars. Ford said she never had heard how George was in bod." (End page 1.)

None of this had saything to do with the assassination or an investigation of it. The one use to which it could have been out in blackwail.

The carginal markings may be "covers. This copy is stamped as having reached his office, via a stamp on the back.
