For the information of all offices, JOHN MARTIN, 1752 Iglehart, Apt. 4, St. Paul, Minnesota, advised he had some 8-mm. movie film he had taken of a group of Cubans after OSWALD was arrested in New Orleans on 8/9/63. Minneapolis then forwarded the film to New Orleans, who reviewed it and found nothing of value. The film was returned by New Orleans to Minneapolis and turned back to MARTIN personally by SA EWALD I. CARLSON on 1/28/64.

On 12/17/63, the Minneapolis Office received a telephone call from JOHN WATSON, 1428 7th Street, Apartment 4, St. Paul, Minn. who advised that he had personally shown 8 mm. reviews of a group of Osborns just after OSWALD was arrested in New Orleans on 9/2/63. WATSON said these films would be available to the FBI if desired.

Without viewing film or knowing coverage by New Orleans, this group of Osborns referred to by WATSON are apparently anti-OSWALD who were against OSWALD and literature being distributed.

New Orleans advise if this coverage would be of interest and if the use of above film would be of any value to New Orleans.
