I did get the Record, wrote and thanked you for inserting the review, and after you had written the letter I just got, phoned to thank again and exchange a few words with your AA on the Freedom of Information suits I've brought.

Although I'm sure we'll never know, I believe one he heard three days earlier helped Casell's understanding when the Post case was before him. It can always be coincidence, but he used a phrase from my complaint.

If you, Ann or your AA do not have time to read the entire book, I think you'll find the final chapter, which deals with my successful suit, both informative and relevant to Herbert Klein's chiding of the Times for not going to court, or using this law. He invites futilities.

I suppose I hold the track record for trying to give this law viability. No major media element has used it, to the best of my knowledge (I can hardly blame them with my experiences).

I've carried my Kin/lay investigations far forward since writing FRAME-UP. It is an even more shocking story than I say, and I have the proof in hand.
