EDITOR'S NOTE TO ACCOMPANY THE PLOT STORY AUTRY

Editor's Note: The following article is a dramatic narrative version of the background of a plot to assassinate President Kennedy, as interpreted by veteran investigative reporter Henry Maddox. The article is based on his own interviews and investigations, and was written especially for New Orleans Magazine with the knowledge and cooperation of District Attorney Jim Garrison. After reading <sup>the</sup> ~~this~~ article, Mr. Garrison told New Orleans Magazine that <sup>it</sup> ~~this is~~ essentially <sup>represents</sup> his theory of <sup>one aspect of the</sup> ~~the~~ plot's development.

Novel first got connected with Garrison by entree through Steven Plotkin; Plotkin was only asst. Garrison cut off some of Novel's income; suffering from lack of funds, Novel tapped Garrison's home phone; subsequently, when Judge Oshara ran against Garrison, one of Oshara's men was Bob Ziblich.
