Dear Sylvia,

I believe Shaneyfelt's will also be available, but I'm not sure. I have just assumed, as perhaps Paul would anyway, that anything of significance you'd want. Unless I hear otherwise, or Paul does, we'll see to it that you miss nothing.

I fear our present melancholies are in some respect similar. Mine do not relate to the case or my work, though I suspect the oppression of what both have meant is intimately intertwined. I presume it is my nerves that are the trouble. I should know soon.

Sprague's piece has not been published except by him. Why not ask him for one? It deals with the tramp pictures and is not good (please do not quote me), but perhaps you might like a copy as a record. If he does not provide one, you may borrow mine. However, I suggest you may want it to keep but have nothing to learn from reading it (nothing constructive, that is). I just got it because he recalled not having sent me a copy. Pretty much the same is true of Ben Cutler's well-intended piece on the magic bullet, where the only thing new is the alteration of his plot by West. Bob is asking \$4.00 for his and will not make money on it then, though it is thin. I can lend also.
