Dear Wallace,

This is not an easy letter for me to write. It also is part of what I regret having to spend any time at all on at my age, at this stage of my life, when any one thing I do is at the cost of another I'll never be able to do.

When I wrote you two weeks ago I did not know what I've learned since then as the need to defend some of us and what many of ^{us} have been trying to do for so long became more obvious and the menace from Harry Livingstone grew and grew.

My only interest in your memo on what transpired at ASK was to use it as an impartial background because the other account I have, from the Baltimore City Paper, according to Harry, is not accurate and, he claims, he took that reporter there and ~~was~~ was double-crossed by him. I'd also had a use in mind I did not include in my letter because I suppose you could not have replied in time and I did not want to use it without your approval. I'd had two appointments with an assistant to the local prosecutor because the extreme nature of some of Harry's vilifications and threat seem to violate an article of the Maryland code and because ^{that is} one of the few protections we can hope for from what I've learned is a rather large campaign against us ^{that} indicates the need for protection.

I've also learned since then that Harry sent you some of those letters. From others I have obtained copies to give the prosecutor and copies to you are sometimes indicated.

I have no interest in having Harry jailed but I do want protection-and he has literally threatened to kill - and I do hope that my effort could lead to his getting the treatment he does need so very much. He once told me he has a past history of this need.

What some of his letters say is that in addition to the current book, which I now think of as High Trash 3^{1/2}, he has contracts for two others. ^{the} The first two are basically flawed and are disinformational. His own description of High Trash 3 is of an atrocity that among other things will have a seriously adverse effect on a popular understanding of the JFK assassination.

When he first indicated to me what he is doing it was before I had any knowledge of the fact that he was off on this campaign which he regards, among other things, as exposure of a non-existing effort to prevent his "breaking the case wide ^{open} ~~open~~." If the case were only an empty bottle he cannot do that. He is in a ~~dream~~ dream world in which he is being used by others some of whom he identified to me. I had questions about one, the FBI, but among the letters I have received, assuming what it may not be safe to assume, that he tells the truth, he and it have a "deal." He refers to spending two hours at one visit with one named in the FBI. That person earlier told me he regarded Harry as only a nuisance. Harry wrote of receiving valuable information from the FBI and even cautioned the Baltimore police working with him to do nothing that could embarrass the FBI or his

relations with it. Among his other sources ^{named} to me is Paul Rothermel, formerly H.L. Hunt's chief of security, and Currington, both fired by the Hunt sons as thieves. Including from them Harry claims to have the details of a monster Texas conspiracy to kill JFK and of a coinciding conspiracy to protect the conspiracy to kill by a cabal of critics, including Mary Ferrell and me. We protect the kill conspiracy by something none of us has ever done, preventing his exposure, "Breaking the case wide open" are his words! *Utterly ridiculous!!!*

All I've wanted from him is to be left alone. I've refused any public comment on his books and I'm not now certain I was right given their financial success, which makes his current evil possible, and the number of people he misled and misinformed.

From what he has said he was due to turn his manuscript in yesterday and the book is scheduled for October publication. Given the profitability of High Trash 2 that I'm told is disclosed in the Groden suit against him and the publisher is reflected by his having been paid about \$180,000.00 as of the last accounting, the publisher will be anxious to publish even if he has questions. That was a very profitable book for him. Still is.

This is the money Harry is using for such things as hiring investigators to investigate Mary and report the nastiest things about her and Buck. Harry actually has, from what he has written and I have, cast Buck as part of the conspiracy to kill by an alleged association with Downtown Lincoln-Mercury with it part of the conspiracy because the killers escaped through tunnels going to it!!!

He has me part of both conspiracy because of lies Rothermel told him, that I "helped" Hunt and was paid for it. He has Hunt and Mary's former law firm as major parts of his vast Texas conspiracy and thus Mary is part of both of his imagined conspiracies! And what he has put on paper about her is so vile I do not repeat it.

He told one of us that it was all he could do to prevent one of those he refers to over and over again as "my cops" from killing that person. And he told me that he was going to kill some of the Texans!

I could go on and on with details of how sick the whole thing is, how utterly impossible and how completely he is persuaded. Some of his basic inventions stem from what he faced because he asked me what to do and he then did what I suggested. He learned from his first study of the Zapruder film which was long after High trash 2 was published, that it shows quite clearly that the back of JFK's head was not blown out, as he ^{it will} says in High Trash 2. And thus it is that he now says the Zapruder film was doctored, that his sick imaginings are the fact and it is not. He has the same position on the Bronson film, which he had never seen, as a result of which he also has Gary Mack one of the alleged conspiracy against him.

My meeting with the local assistant state's attorney was delayed by her sudden illness. That means that she won't be able to see me when she returns to work until after she has taken care of all the ongoing cases. I have no idea when that will be but I hope it is not

too far into the future. At that time I'd like to present all the copies of all the letters he wrote that directly or indirectly include these threats he has made and the various denunciations of us, whether or not named because we are named in enough ^{and} because those denunciations seem to violate the Maryland code. If he attributes an indictable offense to us that does violate it and he has done that often.

In all of this I also want to make a record for history, not only about his monster diversion and disinformation but as a generality, as illustrative of the problems that have had the adverse effect I think I do not have to spell out to you.

So, this time I am asking you for whatever help you can give, including copies of the letters he wrote you that in any way relate to what I've indicated above.

My giving them to the state's attorney's office does not assure that they will be made public. My purpose is to indicate the case, that the offense exists, and I hope to also make it clear that they come from one who is sick and needs the help that I think to a reasonable person these letters will indicate he needs.

If I wanted to interfere with his publication I could not. I would hope, however, given the monstrous nature of what Harry himself says his book includes, the publisher will have some questions. If asked I would then provide copies.

To illustrate the utter insanity of his alleged conspiracy of the critics against him, of those named I have never been in communication with one and had virtually no communication with the others for years, until he laughed this at us!

Harry needs no fact. His sick mind invents it for his as he sees a need. What he imagines then become fact and along with what he is fed by those who are using him he has a book!

I do hope that by addication you will not want to become part of his evil. And I do thank you for anything you can provide to help.

Imagine, poor Buck in terminal illness a conspirator! Along with Mary who is so distressed by so many things, including Buck's condition!

I could add to this but I hope it is not necessary.
