What you say in your 9/15 about using a hand-held CB for emergency communication is what I tried to arrange many years ago. Only there then were no batteries that could be kept with a charger connected. That was when there was only half of the CB band. As I may have told you, when Bill did not use the contraption I forgot and the batteries went bad and ate up that part of the set we now have connected to the aerial. The other one worked. It was 3 watts, smaller for Bill to hold, and I gave it away years ago. The present rig works on the battery eliminator but that means would be dead with no current.

What I have done with that should overcome Bill's feeling that she could not use it. I have instructions written out on the set, Step at a time, and there are few. So, if there are batteries that can be connected to a charger all the time, as with shaver batteries, thanks very much, it can be what we need for if and when the current goes off. (A cousin of our generation and her daughter visited us yesterday. They live in N. Carolina. They have placed down there where the current has not yet been restored after all this time!)

I'd have to dismount the CB to see what kind of connection there is for the coax to the set but I'd hope there is a standard and that the one on the coax would fit.

When we had the rig in place I tried it and we could reach a friend in his car inside the city of Frederick. Our need would be to reach the State police barracks, which is not as far, maybe 5 miles by air. With the aerial that should not be any problem.
