## NIGHT LEAD MINUTEMEN

NEW YORK, OCT. 31 (AP)—A QUEENS CRIMINAL COURT JUDGE TODAY SET BAIL TOTALING \$81,000 FOR 19 MEN ACCUSED OF PLANNING TO BLOW UP PRIVATE CAMPS THEY CONSIDERED LEFTWING TRAINING CENTERS IN NEW YORK STATE, NEW JERSEY AND CONNECTICUT.

THE MEN AND TONS OF WEAPONS AND AMMUNITION WERE DEIZED IN A SERIES OF PRE-DAWN RAIDS SUNDAY IN QUEENS, WESTCHESTER, LONG BEACH AND SYRACUSE, N.Y. OFFICIALS CLAIM THE 19 MEN ARE MEMBERS OF THE MINUTEMEN, AN EXTREME RIGHTWING ORGANIZATION DEVOTED TO TRAINING MEMBERS IN GUERRILLA WARFARE.

THE MEN WERE SPECIFICALLY CHARGED WITH CONSPIRACY TO COMMIT ARSON.

DEFENSE ATTORNEY F. COURTS BOUSE CALLED THE ARRESTS "AN ELECTION GIMMICK." PROSECUTOR HOWARD CERNY SAID THE RAIDS HAD NOTHING TO DO WITH THE ELECTION.

QUEENS DIST. ATTY. NAT H. HENTEL IS UP FOR ELECTION NEXT TUESDAY. HE IS A REPUBLICAN AND AN APPOINTEE OF GOV. NELSON A. ROCKEFELLER.

HE SAID ANOTHER TARGET WAS THE BROOKLYN OFFICE OF COMMUNIST HERBERT APTHEKER.

FBI DIRECTOR J. EDGAR HOOVER, IN CONGRESSIONAL TESTIMONY LAST JULY, IDENTIFIED CAMP MIDVALE AS A CENTER FOR INDOCTRINATING COLLEGE STUDENTS AND OTHER YOUTHS IN COMMUNIST FRONT TACTICS.

AMONG WEAPONS CONFISCATED WERE MORTARS, BAZOOKAS, MACHINE GUNS, SEMI-AUTOMATIC RIFLES, HOMEMADE BOMBS, MACHETES, GARROTING NOOSES AND A MILLION ROUNDS OF AMMUNITION.

POLICE SAID THEIR INVESTIGATION BEGAN LAST JANUARY.
