All that holds back the White House from referring the charges to the FCC, an aide told this column, is concern that the motive might be misunderstood.

Since Vice President Agnew's attack upon the TV networks, CBS has been the boldest about continuing its criticism of the Nixon administration. Some aides fear, therefore, that an FCC investigation would look like an attempt to intimidate CBS.

The White House memo, charging that CBS has been involved in "highly questionable activity," cites these alleged incidents:

The CBS news department (1) faked horror scenes from case." Vietnam on at least three occasions; (2) planned "a staged invasion" of Haiti; (3) "staged incidents of police brutality" during the 1968 Democratic convention; and (4) arranged to film an illegal "pot party" in Chicago.

Since this report was prepared for the U.S. mission in Saigon it may be discounted. In the opinion of this observer, a carefully planned and thought-out program of asylum, with far more reality than is now in sight, must be evolved. United Nations supervision is surely the smallest pre-requisite. That would help to ease American withdrawal since, obviously, given the state of opinion in this country, American troops cannot remain indefinitely to insure against catastrophe.
