The FBI's 8/17 and 10/4 letters appear to be normal. There is a questionable sentence but I doubt it has significance. his is the ststement that all the DL records are preprocessed and at FBIHQ. The possibility of significance is it the DL copy, or copies of the Moorman pix were not sent to FBIHQ.

.Mour letter to the former Mary Moorman is quite good. I look forward to the rest of what we discussed on this.

For my own purposes I'm separating the copies of the records the FBI sent you for filing by subject, with a copy of this, the Jean Hill stuff with Moorman. I read it some hours ago but recall nothing new in the Poorman records.

All are FBIHQ records. 105-82555-2028 refers to several items by their numbers in previous correspondence. When we spoke you thought they'd excised what relates to Item 13 because of the white space. I think not, that it would have been backed out if excised, and that they started on the next pages because they were close to the bottom of that page.

I find it interesting that DL did not in any of these records disclose to FBIHQ that it had made any copy, even after HQ raised the question. I do not believe that once the question was raised it kept any secrets from FBIHQ, so I proume there are other records, even if the matter was handled by phone.

After going over these records I see no explanation for the selection of irrelevant records included in what was sent you. I presume it was some kind of accident, perhaps parts of several other requests.

When you told me about the 1965 Philip Geraci records I wondered about the FBI's interest as of them but the records are self-explanatory and also accurate. Albeit incomplete. An explanation is in order.

That Geraci and the other boys planned those right-wing extremist operations is correct and they were properly reported to the FBH by Jeff Parish and to others by the FBI. I conducted a fairly complete investigation of Geraci for other reasons, interviewed his father, his mother twice and him the second time I spoke to the mother, in the presence (indeed, home) of the family lawyer at my arranging. That the FBI carried its work no farthur, or its interest, appears to be a little unusual and I'm inclined to believe that it did, whether or not those additional records are omitted by accident. There was another young person involved, a girl who was both a source-informer for me and a narcfink. She is not mentioned. It is she who met Geraci when he returned to N.O., and then something out of the ordinary happened. He went to see Bringuier, who instead of informing his parents or the police, arrainged for him to stay at a dive known as The Silver Dollar, and there he was the victim of a gangbang. (I think the boy was gay and that he was honest with me.) This and another Bringuier factor may account for the incompleteness of what was sent you. The other factor is that Bringuier was, as I told you, a liar to have an alibi for something else. Bringuier placed the date of Oswald's visit to him at 8/5/63 (also in other records 8/2) and thus, because of the raid on Ricardo Davis so-called camp on the other side of Lake Pontchartrain Bringuier was suspicious. The initial FEI reports quote win Garaci as placing the date as perhaps in July. (The raid was 7/31.) They also quote Geraci as saying this was his first visit to Bringuier. His first visit was much earlier. I have copies of receipts Bringuier gave him that are, as I recall, in June, provided by father and mother from a shoe-box of such stuff.

Philip was in Vietnam when I saw the parents, and both were cooperative. I taped the interview and played the tape back to them for any comment. None.

The mother's recollection was quite clear. Philip and Vance Blalock were both in the CAP and wanted things for their uniform, perhaps overseas caps. The mother had a dental appointment not far from or in the French Quarter, it was right after the end of the school term, and she drove the boys to the Quarter for them to get what they wanted. That was the first time Philip was there. (He was to see Bringuier fairly often afterward.) So the actual time was not long after LHO got to NO and coincided roughly with his getting his literature and picketing the Wasp.

With regard to the older gay "Mario," the father told me more, where he picked boys up, of complaining to school authorities, and the other descriptions, from him, the girl and I'm not now sure, Philip, it may have been Mario Bermudez, a Shaw crony. I emphasize may because it also may not have been and there is no certainty.

NO put two different file numbers on its copies of the first two records, 105-2467 on the 5/5/65 teletype and 100-2467 on the 5/6/65 airtel. 105 = Foreign Counterintelligence and 100= Subversive Matter. The airtel also is on a printed form, with boxes to be checked. "Bombing Matters" is checked, "Racial Matters" isn't. But "Bombing Matters" is not ordinarily filed in 100 or 105. Ordinarily 174, and the original at FBIHQ was filed in 174-1-133?7. (Somehow the 2467 seems familiar but I cannot place it.)

What appears to be unusual and I think indicates an omitted record or records is not correcting the comparation in N.O. file numbers. Either N.O., FEIHQ or both would have done this.

I have a copy of the Jeff. Parihs juvenile report and as I recall it the name of the sergeant is spelled "Bourne." I think it is very unlikely that he did not provide his later info, which involved Pringuier and the gangbang (as I recall given as a single rather than a gang) and the girl's role and what then happened to Philip (mental hospitalization) to the FBI. Not included in what you got.

Also odd is the fact that one of the 1965 records bears a visible FBIHQ file #. It is both Not Recorded and serialized on the TT of 5/5, not normal, and only the serial numbers appear on the others. Most likely Oswald, 109-82555, but cauld be JFK, 62-109060.

Livewise odd is the fact that the Lowell Brandle records which follow also follow in alphabetical serialization of 5414, Geraci ending with and Brandle beginning with C. (This might be from later insertion into a file or from a purpose other than filing serialization.) A new FBIHQ file # is given these records. Two of the FBIHQ #s at the end of F are knwon to me, 104401 has John Birch Society records and 107261 Minutemen records. 62 Miscellaneous, non-subversive. This story, of the reporter trying to get a rifle when he used the name "Hidell," is well known. (I can(t make out the San Antonio record, also F, and I'm placing this in my Klein's file. ** (Lub.3)

The remaining records relate to "corman and Hill, from 105-82555. In a sense a little provocative but not inconsistent is Hill's statement that she "saw the hair on the back of" JFK's head "fly "FB." Not the top of the head. That a piece of scalp went more or less up is not new. Not FBI followup on this indicated here. (Serial 2677.) On p.3 Hill says that a federal agent asked her how she felt when a bullet hit near here feet. This suggests that if you can locate her you show her the picture I suggested you ask Schott to look at, the one with an agent with Buddy Walthers, picking something up not far from where Hill had been. 105-82555-3464, that no exhibit numbers were assigned by DL to the four 'claroids of Tip it's wounds because DL did not know if HQ would be giving them to the Commission reflects the general field office knowledge that the FBI was not giving everything to the

Commission and if unusual in that the FBI required its own identification numbers for its own purposes and investigation. It knew the Tippit killing was included in the Commission's mandate, too.

But in not giving these to the Commission, if in the end it didn't, the FBI was exercising a kind of control over the Commission. (My file, FBI Commission relations. Also Tippit killing.)

copy of which was exhibited by SA MOORE, was the automobile occupied by President KENNEDY, which photograph was apparently made shortly after President KENNEDY was struck by a bullet fired, by the assassin. The ISBD Building does not appear in this photograph at all, the entire photograph being filled with the President's automobile. The photograph shows Fresident FENNEDY leaning slightly forward to the left with Mrs. KENNEDY in a sitting position in the car. This photograph appeared in many newspapers throughout the United States and a copy exhibited by SA MOORE carried a Dallas Times dateline of 11/23/63. Information appearing under the photograph reflects the photograph depicts "KENNEDY hit by assassin's bullet...photograph made by Mrs. Mary ANN MOORMAN, wife of Dallas plumber with Polaroid camera."

Investigation to date has identified a number of persons who attended social functions at Dallas, Texas, with those persons having been interviewed and/or investigation is in progress to locate others and they will be interviewed. Regarding OSWALD's address book, all leads suggested in that address book, which writings appeared in English as well as Russian, are being pursued and results will be reported to the Bureau in reports as the investigation is completed. It is noted that the majority of persons who had been indicated to attend social functions with the OSWALDs had already been interviewed before the receipt of referenced Bureau airtel by the Dallas Office.

Alt is noted in an earlier report in this matter Mr. O. V./CAMPBELL, Vice President and Secretary, Texas School Book Depository (TSBD), Elm and Houston Streets, Dallas, Texas, advised on November 26, 1963, that while he had not observed anyone fire any shots from his building on November 22, 1963, he had observed an individual wearing a construction-type hat who was talking about seeing an individual fire from the window of the TSBD Building, and he noted that a police officer bad taken this individual's name.

On December 17, 1963, Mr. CAMPBELL advised SA REPUFTH B. JACKSON that as best he could recall this individual was wearing a white helmet and work clothes with possibly red lettering on the belmet. He described the man as white, about 5'9" or 5'10", possibly 165 pounds and possibly around 35 years of age. He said that this man was talking with a Dallas Police Department officer.

A review of information in this matter indicated that the individual observed by Mr. CAMPBELL may possibly have been identical to HOWARD LEGLIE BRENNAN who has been proviously interviewed in this matter.

On December 17, 1963, ERENNAN advised SA KENNETH B. JACKSON he was employed with Wallace-Beard Construction Company as a steam fitter, and he was doing prefabrication work at a location to the rear of the TSBD Building on November 22, 1963. He is still employed with this company but is now working at the construction site of the Republic National Bank Building, Dallas. He stated he continues to reside at 6814 Woodard, Dallas.

On December 17, 1963, PRENNAN was introduced to Mr. O. V. CAMPBELL by SA KENNETH B. JACKSON, and neither individual showed recognition of the other at first. Mr. CAMPBELL was of the opinion that BRENNAN was very likely the person he had referred to as having conversed with the Dallas police officer immediately after the shooting of President KENNEDY on November 23, 1963. He indicated that possibly his recollection of a white construction-type helmet on the individual he had observed could possibly have been a gray helmet which, according to BRENNAN, was what he, BRENNAN, wors on November 22, 1963, with the name of his company, Wallace-Beard, stenciled in black letters on the

front of the helmet and at that time a small black name sticker bearing BRENNAN's name. Mr. CAMPBELL observed a round, white badge bearing a number, 130, with the words Wallace-Beard Republic Bank Tower and indicated that possibly his recollection of red letters on white background could have been from observing this badge which badge, according to BRENNAN, was worn by him on November 22, 1963, . as at the present. The entire badge was not in red lettering, but the large digits 130 in the center were in red, the word Wallace was in blue letters, the word Beard was in red letters and the words Republic Bank Tower were in blue BRENNAN furnished his own description as white male, 5'72", 155 to 160 pounds and age 44. As CAMPBELL and BRENNAN talked Mr. CAMPRELL stated he became a little more sure that ERENNAN was the individual he had seen conversing with the Dallas police officer on November 22, 1963. Mr. BRENNAN stated that he was unable to recall CAMPBELL at all but remarked that he himself had talked to a Dallas police officer at that time and that CAMPBELL could have observed his conversation with the police officer without his own knowledge. BRENNAN did state, however, that he felt reasonably sure that the person referred to by CAMPBELL would have been himself.

Mr. R. S. TRULY, Superintendent, TSBD, stated that he was in company with Mr. CAMPBELL on November 22, 1963, at the time the motorcade of President KENNEDY passed in front of the TSBD. He stated that immediately after the shooting at that time he and Mr. CAMPBELL apparently became separated by the surging crowd, and, therefore, he would not be able to comment regarding any persons observed by Mr. CAMPBELL at the time. Mr. TRULY furnished this information to SA KENNETH B. JACKSON on December 17, 1963.

The Secret Service further advises us that this photograph has been returned by your Bureau to Mrs. Moorman.

If the Bureau did obtain this photograph from Mrs. Moorman, do you have a copy in your possession? If you do not have a copy and if in fact it has been returned to Mrs. Moorman, we would like you to obtain this photograph from her with the assurance that the photograph will be promptly returned to her after it has been examined by the Commission.

MARY AND MOORMAN, 2832 Ripplewood, telephone number DA 1-9390, advises that she and a friend hamed JEAN HILL, 9402 Bluff Creek, Dallas, Texas, watched the President KENNEDY parade from the grassy area in the parkway between Main and Elm Streets, and at approximately 12:25 p.m., as well as she recalls, she took a photograph of the procession as it proceeded toward her. She took this photograph with a polaroid camera, and the photograph showed the police motorcycle escort preceding the President's car. In the background of this photograph she said the Texas School Book Depository Building was visable.

She took a second photograph of the President as his automobile passed her, and just as she snapped the picture, she heard what she at first thought was a firecracker and very shortly thereafter heard another similar sound which she later determined to have been gunfire. She knows that she heard two shots and possibly a third shot. She recalls seeing the President "sort of jump" and start to slump sideways in the seat, and seems to recall President KENNEDY's wife scream, "My God, he's been shot"!

Mrs. MOORMAN states that she and her companion fell to the ground, but does not now recall what prompted her to fall unless it was the reports and the commotion in the President's car. She says she must have instinctively realized that there was shooting, but does not recall actually thinking about it. She states that she could not determine where the shots came from, and her next recollection is of people running more or less aimlessly, it seemed to her. She recalls that the President's automobile was moving at the time she took the second picture, and when she heard the shots, and has the impression that the car either stopped momentarily or hesitated and then drove off in a hurry.

She stated that as the President's car drove off she started to leave the grassy area and was stopped by a Mr. XFEATHERSTONE, a newspaper man with the KRID Radio And TU

Special Agent MINES MODER, United States Secret Service, 505 North Ervay Street, Dallas, Texas, exhibited the following photographs in possession of the Service which photographs were taken by Mrs. Mary And MODEMIN, 2832 Ripplewood, Dallas, Texas, on Movember 22, 1963. Both photographs were made with a polaroid camera.

The first photograph is of very poor quality, being extremely light and exhibits a lower sormer of the Texas School Book Depository Building. No view is shown in the photograph of the upper floors of the building and particularly the windows on the sixth floor Trem which shots were fired at President JOHN P. KENNEDT on Movember 22, 1963. The principal subject in this photograph is a Dallag policement of a motorcycle. No other parts of the Presidential metersale are seen in the photograph.

A second photograph taken by Mrs. MOORMAN was sold to the "Associated Press by Mrs. MOORMAN. This photograph, a copy of which was exhibited to SA SHARLES T. BROWN, JR. by SA MOORE, of the Secret Service, shows the automobile occupied by President EKNNEDY which photograph apparently was made shortly after President KENNEDY was struck by a bullet fired by the assassin. The Texas School Book Depository Building does not appear in this photograph at all and the entire photograph is filled with the view of the President's automobile. The photograph shows President KENNEDY leaning slightly to the left toward the position in which Mrs. KENNEDY is sitting in the ear. This photograph appeared in many newspapers throughout the United States and the copy exhibited to SA BROWN by SA MOORE earries a Ballas, Texas dateline of Kevenber 23, 1963. It is indicated to be a "(AP Mirephoto) (ris 71555 eer) 1963. Mrs. Moorman was taking photographs of the motorcade as it came into view and when the car occupied by President Kennedy was passing Mrs. Hill, she recalls shouting, "Hey!" She stated President Kennedy was looking down when she shouted, and when he turned to look

at her a shot rang out and he slumped toward Mrs. Kennedy. Mrs. Hill heard more shots ring out and saw the hair on the back of President Kennedy's head fly up. She stated she thought Mrs. Kennedy cried out, "Oh, my God, he's been shot!" As the President fell forward in his seat Mrs. Hill knew he had been hit by a bullet. Mrs. Hill stated she heard from four to six shots in all and believes they came from a spot just west of the Texas School Book Depository Building. She thought there was a slight time interval between the first three shots and the remaining shots.

When the firing stopped, Mrs. Hill noticed that everyone in the vicinity seemed to be in a trance wondering what had happened. Mrs. Hill recalled it was then she noticed a white man wearing a brown raincoat and a hat running west away from the Texas School Book Depository Building in the direction of the railroad tracks. She said she does not know why but she started across the street in an effort "to see who he was." In so doing, she ran in front of the motorcycle escort following the President's car and was nearly hit by one of the policemen. Mrs. Hill said she lost the man from view when she looked down at what she first thought was a block spot but later determined to be a red snow cone. She did not get a good look at this man, does not know who he was, and never saw him again. She thought the man was of average height and of heavy build.

Mrs. Hill then rejoined Mrs. Moorman where she had left her, and they started to leave the area. They were stopped by Mr. Featherstone, a Dallas newspaper man, who took them to the press room at the Dallas County Sheriff's Office.

Mrs. Hill stated she and Mary Ann Moorman were at the Sheriff's Office for about two hours and were questioned repeatedly by representatives of the press and various Federal and local law enforcement officers. She said the Sheriff's Office was a scene of extreme confusion and it was impossible to remember what questions were asked of her by the Secret Service Agents and Federal Bureau of Investigation Agents. She recalled that a man identifying himself as

either a Secret Service Agent or Federal Bureau of Investigation Agent asked her what she thought when a bullet hit near her feet raising the dust. Mrs. Hill told him she had no recollection of a bullet hitting near her feet. Mrs. Hill told the Agents she heard from four to six shots and heard one of the Agents make the remark, "There were three shots, three bullets, that's enough for now." She advised that at no time did any Federal Agent or other law enforcement officer attempt to tell her what she should say in regard to the number of shots fired or to force any other opinions upon her.

Mrs. Hill advised that about a month ago she received a long distance telephone call from Mark Lane, a New York attorney, who questioned her regarding the assassination of President Kennedy. Mrs. Hill stated that from reading some of Lane's statements regarding this conversation she determined that Lane had taken some of her remarks out of context, thus changing the meaning of her replies, had not used her full answers to some of the questions, and had misquoted her in this conversation. Mrs. Hill stated Lane asked her occupation and she replied she was a housewife. This point was pressed by Lane and Mrs. Hill told him she did some substitute teaching. Lane told her this was great because teachers made very good witnesses.


