What you have done with the vehicles is exactly what I wanted. I would like to ask that you also send copies, when you can, to the following people, each with a note saying I asked you to so they will know why they are getting it, why you did it - so that you will have, so to speak, suspects.

I have read your exhibit in haste, but it seems pretty complete. I would suggest that you include several others that I think are in OSWALD IN NEW ORLEANS (unless it was edited out), if not referred to in WHITEWASH (Chapter 11) or WHITEWASH II (Chapter 7). Loren Eugene Hall used at least two cars, one he is said to have delivered to the west coast from Florida, and one his own, I believe a 56-8 Oldsmobile. Lawrence Howard, I now know (and I know of no reference to it) also used his own. Then there is the car used by two men whose position and car were left deliberately vague by Wesley Liebeler. This is the incident of the out-of-State car Evaristo Rodriguez and Ruperto Pena reported to the FBI through Carlos Bringuier. I think these may be important vehicles to identify in the future. Having a record of them in your exhibit may be helpful. Also, you may pick up other things relating to them.

There is an additional pickup, which may be the same as one in your list, identified with a man who was at the Sports Drama range. The owner was a large man, as I recall it, also bearded, who was also connected with a perhaps memorial-carving company. I have a vague recollection of this from some archive documents I saw and could not afford to get copied. Part of his story also was that there was supposed to have been a man identified as Oswald who once applied for a job there and left some clothing behind.

I wanted you and Sprague and you and Marcus to be in touch with each other, that is why I wrote as I did, giving you their addresses. I will be in Chicago in 10 days. If there is anything to be followed down on the Similes investigation you have been conducting, please let me know. If I cannot do it myself I'll ask someone else to do it. I understand about seeing Jefferies. Anything else? I'll be there only overnight.

Yes, Dick did send me a copy of his observations on the first hour of the 62 hours of newly-located film I directed him to. We may find more the same way. I have two other similar leads. When he and I can do it together, we will try and examine some of the balance. When you communicate with him further on this, remind him of the local TV stations' inventories and records of their footage that I brought to light in WHITEWASH II. It is possible that he got copies, which I could not afford (one ran to 128 pages). There may be more data in these documents, if he has them.

Before you go to New Orleans-before you make definite plan-be certain that the Shaw trial actually does begin that day. The only place I've stayed there is the Fontainebleau Hotel, which is very nice. Costs about \$12.00 a day and is on a direct bus line to the courts building. I doubt if you'll be able to get in to the court. There is more prospect that the trial will not begin 2/13 than that it will, in my opinion.

I do not have the full Times story on the family-GSA contract, although I presume I am responsible for the release of this documents. I'd like a copy if you can spare it. I have the original documents and do not need that part of the Times story. I'd appreciate the full text, because what is on the jump page, which I have, may be different in different editions of the paper. Your observation is correct. How can those who didn't see them say what they show? Indeed, they can't. Could you amplify your opinion that the doctor lied on CBS. I do not follow that. That is, in this context. He did lie, but in other ways. These doctors were shown the pictures and X-rays 10/31/66.

The man at the Archives is Marion Johnson. Addressing him at the National Archives, Washington, D.C. will reach him. I just really cannot now take the time to make a copy of the CIA in NY exhibits. When I can, I will.

Returning to the date of the Shaw trial, I think it not possible now to estimate it. That will depend on the legal maneuvers of the defense, and the judicial reception. I anticipate a couple of nasty ones, aside from those that are obvious.

As to the wisdom of your going to New Orleans, that I cannot say. I think it unlikely you will be able to get into the sessions, but I can be wrong. I think you would enjoy New Orleans, however, and seeing the various places that are part of the story. If you go near Rene's bar, remember, that is a very tough area, especially at night.

I have no publishing date now set. The fifth book has been done for months. I just cannot now risk the additional debt.

Please excuse the haste.

Dear Sir:

I am sending you an exhibit I have worked out on which you will find listed the vehicles observed in and around Dealy Plaza on Nov. 22, 1963 that may have played some part in the actual assassination. I believe that it is fairly self explanatory. I tried as best possible to arrange the sightings in chronological order using the time of the sightings as my guideline. Part II is a partial list of cars sighted that may have played some part in the story of the "False Oswald." There will undoubtedly be revisions and additions to both to which I will keep you informed.

You probably have the latest sheet from Dick Sprague on which he has listed some of the highlights of the first hour of listening to the 12,000 hrs of videotape that you recently discovered. In the first hour Dick mentions that a Fort Worth station mentioned the arrest of a man with a green car. I have found, and you will find listed, some further aspects of this arrest and car in my exhibit, including the cars license no. Do you think that possibly Dick would like a copy of this exhibit? I can send him one if he does.

Mr. Sprague and I have corresponded on the Similas affair and I have sent him my work on this subject. Perhaps he has been in touch with you. I believe some of the recent developments are new and interesting. Also I have taken the liberty to write Penn Jones, Ray Marcus etc. Thank you for their addresses.

In the New York Times for Jan. 6th, 1968 there was an article entitled "Accord on X-Rays of Kennedy Bared." Perhaps you saw and have a copy of it. Some of it I would like to comment on. In the 3rd paragraph, page 1, there is a statement that those who have seen the X-rays, photo's etc. "say they give strong support to the Warren Commissions conclusion that Lee Harvey Oswald acted alone in killing president Kennedy." The article then states, page 15, column 1, 2nd last paragraph, "Although Government investigators and persons approved by the Kennedy family could have been permitted to see the autopsy during the first five years, Dr. Bahmer said no one had in fact seen them. No government agencies have asked, he said, and Mr. Marshall said he would not authorize any private persons to see them until Oct. 29th, 1971." If no one has seen them, then how can they state that they give "strong support" to the Commissions conclusions? Besides contradicting itself this article also brings out another interesting point. If what Dr. Bahmer says is true, and I have no reason to doubt him, then it means that certain people have told blatant and outright lies. Included is our friend Manchester, and I think more importantly, it means that the medical man who testified in behalf of the Commission last June in the CBS four-night special (Dr. Boswell I think) told an outright lie before millions of people when he said that he had reviewed the X-rays, photo's etc. and that they did not change his previous comment concerning number of shots, points of entry and exit etc.

When you last wrote you gave me the name of a man from whom I could buy documents from without going to the Archives. However, you forgot to give me his address and therefore I have not been able to get in touch with him. If you can give me his address I would appreciate it. Also, if you do have time, I would still like a copy of the suppressed documents that you used in the writing of the Oswald In New Orleans book. I might add that book sales have indicated that in Toronto this has been your best selling book to date.

I have saved up enough money to be able to take a trip to New Orleans next month when some of the Clay Shaw trial is on. Do you know when the trial is due to start? If you could give me a date I would appreciate it. Also if you could give me some ideas of the hotel accomidation, rates etc it would be useful. I only ask you this because you have been before and know more about these things than I. I am going down to take some photo's and to have a look around ~~at~~ at some of the places that have played a part in the hatching of the conspiracy. If you do not think that it is wise for me to go please let me know. I realize that it will probably be well covered by the press.

Do you have any future publishing dates set yet? I hope so as I am eagerly awaiting your next writing on this subject.
