Dear Jeremy,

As I'd feared earlier, the January 6, 1998 "Release of Documents to NARA" appears to be incomplete and without the FBI file numbers will be difficult for those intending serious research to use. It is only when the list gets to the nut stuff that has no connection with the assassination that it includes those numbers which are the cited sources, where sources are cited, in just about all books published to now.

The Dallas office and headquarters had a Ruby PSI file that has not been disclosed. It should have been given to me in CA 78-0322 but it wasn't. Each time the agent saw Ruby he filled out a form for the file kept on PCIs, of whom, with headquarters approval required, Ruby was one.

There is no identifiable de Mohrenschildt 105 file, but those of the Dallas office and headquarters were disclosed to me. I believe there was one 105 file on Marguerite Oswald and perhaps on Marina, I'm not now sure.

New Orleans had a Garrison file, it had Garrison information filed as SOs and it had a Garrison tickler, not disclosed to me in CA 78-0420. It also had information it did not disclose to me on Clay Shaw and David Perrie but the existence was disclosed to me in other ~~records~~ records.

The Archives should include the FBI's file numbers on all those records. Without necessarily intending suppression, it is already in the position of denying having what it was forced to disclose to me in an FOIA lawsuit. It claims it has no executive session transcript for January 22, 1964, but it not only provided it to me, I published it in facsimile. It clearly has not filed that transcript with the other transcripts, where it should be.

The Commission decided not to continue with the court reporter there and to not have him type up what he had recorded. When the stenotype tape escaped the memory hole and I pinpointed where it was the Archives sent it to the Pentagon rather than to the court reporter and it was transcribed and disclosed.

The FBI also had information on the critics in the DeLoach 94 files. From this list it is not possible to be certain that what was ~~disclosed~~ disclosed to me in FOIA litigation has been given to NARA.
