Harold, I am going to have to reprint Waketh for its 3rd printing! It is so thick that I cannot ad the Epilogues, I'll eventually have to have them printed separately. Do you want me to ad anything to Waketh? I may do XXXXX new foreword. I may ad the article about the faking of the Gulf of Tonkin involving Adm. Stockdale. Also, I may ad the CHAOS memo. This is my nickname for the memo that states the US might undergo a lot of turmoil in the Fall of 1963. I'll dig it out and show you the one.

Things are going well for us. Betsy and I were discussing dates to come up there. Still undecided.

Forgot to ad, Bill Pepper is being sued by the guy he thought was dead, who he has implicated in King's death. Eidson or some name like that.
