I had not heard of retired Adm. Moorer's comments on the matter. Most of what I heard regarding the missile theory were put-downs of Pierre Salinger's views. Certainly, given what we now know about the Navy regarding the Gulf of Tonkin "incident" and what Harold exposes in Never Again! and Waketh, I would not put a cover-up past them. Your idea about preparing exhibits to show in the context of giving talks on JFK and King is a good one. I have done a little bit of that. When Stone's movie came out and I got a lot of invitations to speak locally and appear on the state education TV, I did a little bit of that. For example, on a call-in TV program I got the moderator to set me up with a question in which I commented on Howard Willens' statements denying a cover-up. I pulled out a copy of the Katzenbach memo of 11/25/63 and showed that this memo had been dredged from Howard Willens' files (HPW, in the lower corner of it). In classes I usually try to give students copies of documents. But you do have to make sure you put it in the proper context either in your speech or on the exhibit itself. As time passes, there is less and less knowledge about even the most basic and obvious facts surrounding the case. This was brought home to me recently, on a humorous note, by an exhibit of old newspapers our library has on display. There were two papers from that time: 11/22/63 and 11/28/63. The 11/28 edition of the Spartanburg Herald/Journal has an Ap Wirephoto of JFK, Jackie, and Gov. Connally all sitting in the back seat! Connally is sitting right next to Jackie. That certainly would have made the impossible single-bullet theory even more impossible. But it is an obvious fake. I suppose someone thought it would be nice to try to capture all of the principals in one

Regarding your plans to visit Harold & Lil, keep me advised. It is possible I may try to hook up with you in April. I know Dennis MacDonald wants to visit. He recently gave appaper at an American Criminal Justice conference in Albuquerque, N.M. on the Dallas police's bungling in the JFK case. He has done some work on it, while I have not done much at all during the past year.
