Help has been so scarce any suggestion of it warms me. Prospects of it have been so slim, I've never thought out what to say.

If you have read two of my books, there are/more printed you haven't read and four more done and in limited (xerox) editions only, and a number already started, two completely researched. This give you an idea of the magnitude of what I have undertaken and what I think I have, to a large degree, already done.

And if you are shocked, as most thinking people are, by what you have already seen, that is nothing to what I now have and is unknown. This ranges from really dishonest staff memos showing the lawyers knew better (on the most basic evidence, the importance of which was not lost upon them) to irrefutable proof of the destruction of evidence (together with the replacement in some cases and secret memos describing it in others), including even receipts for this destruction. Where it was done, how, by whom, the whole package. I have the most vital evidence that was withheld from the Warren Commission (had it not been they could never have issued this report). I have irrefutable proof that the President was shot other than as officially claimed, other than where officially alleged - and who knew and recorded it and remained silent, denying the evidence to the Commission.

And this is not all. It is some of the more dramatic. It is all official. Oh, it is worse than even this. I have now caught the government altering the existing evidence when they caught on that I correctly understood what it shows. I now have official pictures proving this - before and after. Is there any freedom, integrity or future in a country where this can happen? Is anyone safe?

Perhaps if I explain my circumstances and where I am in my work, you can then decide for yourself what, if anything, you would care to do. I wish, however, that if you and/or others are deeply interested and willing to aid in a position to help, you could come here and see that I am not exaggerating, not misrepresenting what I tell you I have. You would then also see how I got it.

I am now in the seventh year in which I have done nothing else but try as best I can to do what the government did not, really investigate the assassination. In this time I have had no income or subsidy. What return there was from my books fell far short of the actual cost. This and the cost of this continuing work have put me about \$40,000 in debt. It is for this reason I cannot continue to print the books I continue to research and write. Just finding the money to pay the interest is a major problem quarterly. I can no longer afford even the usual supplies. This typewriter, for example, is beyond decent repair. My wife, who has done an enormous labor, has taken four months of outside employment a year on which we try and make out. This also reduces our output.

If you read "HITLERBACH", my first book, you may recall that I early seized

upon the autopsy as one of the key things. What I have in that book is definitive as of the information available at that time. As I could resurrect the suppressed evidence from its official oblivion, I used it where appropriate, as in the second part of the second book, WHITEWASH II. Then I got enough in addition to do a book on the autopsy and what I believe is relevant (in some cases not directly dealing with the autopsy). Although I completed it in the late summer of 1962, it is still new and fresh material. But I couldn't get it published. So, I continued my work in this area also. I have completed the third of a three-part study of the autopsy under the general title POST MORTEM and have researched the second part. I cannot begin to summarize what this includes, but it is more than total disproof of the official fairy-tale, more than overwhelming proof of monolithic, deliberate dishonesty. It is proof of law-violation, including perjury and the subornation of perjury, proof of a conspiracy within the government to hide and misrepresent what really happened.

I have done two books on the three major assassinations, the first part dealing with all three as a coup d'etat (and bringing to light a great amount of material officially suppressed, including known threats to JFK and King by the most extreme of the rightist extremists, protected by the FBI and the rest of the government) and the second with the King murder alone. Here also the official account is fiction, but I also have the proof that this was contrived, how it was contrived and by whom. There was a conspiracy, Ray was part of it, but the evidence proves he was not the shooter - and the FBI and Memphis authorities knew this. Here I have enough, according to a reputable and competent lawyer, to justify what we cannot expect, the disbarment of all the lawyers involved on both sides. It is simply incredible but it is also beyond question, my documentation is that thorough. Among the proofs I have are Ray contracts with his lawyers, the official form of the "evidence" before the inquest and the false representation of it in court, where there was no opposition. Together, this is one very large book. I am adding a few notes now, but without them it is almost 600 pages, 85 of which are appendix - photocopies of suppressed evidence. When you consider that in the form in which I prepare for these "underground" books I have brought out by offset reproduction of the typescript there are 600 or more words per page, you can see the size of this work.

When I complete the autopsy writing, I will resume a book titled AGENT OSWALD. I believe there is a prima facie case he was and I have much of what was hidden on this. Also part of what was destroyed.

There is more, but I fear wearying you with details. I hope this is enough to indicate the scope and success of my work. From the two books you have read, I hope you believe it is both complete and solid.

Aside from our personal needs (and we have learned to live with the worries and restrictions this work imposes), the area in which I would most welcome help is in being able to bring these books out - to be able to print them. There is no prospect of commercial printing. There now isn't for any honest, responsible work. While private printing severely restricts the sales possibilities, it does make information available, it is possible to seal it, and my first book, in this form, is the first on the subject. I believe it and the attention I was able to get for it really opened the subject.

If you could but see what I now have, I think you would agree there is nothing like it in the history of representative government and you would want it to be made available, for the present and as a record for the future. I hope you will find it possible to help, and I do thank you for the willingness to consider it. If you have any questions, please ask them.
