Writer: Oswald Didn't Kill JFK —Dallas Police and the FBI Did

WASHINGTON — A former computer specialist for the Central Intelligence Agency today claimed that Lee Harvey Oswald was innocent of the assasination of President John F. Kennedy and suggested that the real murderers may have been the Dallas Police Dept. and the federal Bureau of Investigation.

George O'Toole, 38, made the claims at a press conference which was conducted to promote his new book, "The Assasination Tapes," an electronic probe into the murder of John F. Kennedy.

O'Toole said Oswald ap-

parently was telling the truth when he claimed he did not kill the President, who was assassinated Nov. 22, 1963 in Dallas.

He said tapes of Oswald under questioning by reporters were analyzed on a "psychological stress evaluator" (PSE), a new type of lie detector that examines the human voice.

O'Toole said PSE analysis finds "Oswald was telling the truth," when he told reporters, "I didn't shoot anybody."

O'Toole, who said he posed as a newsman and used an assumed name in Dallas in recent years to gain information on the JFK slaying, devoted many pages to the hypothesis that "Lee Harvey Oswald worked as an informer for one or more FBI agents in the Dallas area."

He develops the hypothesis to a conclusion that one or

more Dallas FBI agents, acting as individuals, helped to frame Lee Harvey Oswald.

O'Toole said Oswald's widow, Marina, probably was forced to give testimony to the Warren Commission that was unincriminating to her late husband under fear of being deported back to Russia, her native land, if she did not cooperate.

Page after page of the more than 265-page book examines the stress in the voices of police officials who were involved in the capture and interrogation of Oswald before Oswald himself was shot to death in the basement of the Dallas City Hall less tha 48 hours after President Kennedy was slain.

O'Toole claims the PSE showed stress or lying by such people as Lt. Gerald Hill, who led a contingent of policemen in the capture of Oswald in a theater.

O'Toole strongly implies that the police and FBI did the following things:

• An FBI contact told Oswald to answer a telephone in the Texas Book Depository at the time Kennedy parade was passing the building.

• FBI agents and Dallas policemen not only framed Oswald for the Kennedy slaying but also framed him for the slaying of Policeman J.D. Tippit, and that Oswald was only in the theater to meet his "contact."

• Dallas police, according to the book, already knew whom they were looking for when they captured Oswald. The only reason they didn't kill him in the theater was because the other patrons inside the theater would have

Continued from Page IA seen them do it, the book says.

The book and O'Toole made no mention of what really happened inside the theater when Oswald, upon seeing the policeman, jumped up, yelled: "This-is it" and tried to future his pistol—the same one that had earlier blown Tippit's head off—into the head of another policeman.

The gun failed to fire, giving police and sheriff's deputies an opportunity to wrestle him to the floor and take the gun away from him. Nor does O'Toole mention that as

he was being escorted from the theater that he chanted a familiar slogan: "police brutality, police brutality."

O'Toole theorized that not only had Oswald been an informer for the FBI but that some of the FBI agents in Dallas — acting as individuals — may have been in volved in the assassination conspiracy and used Oswald to "entrap him into self-incriminating actions."

The book is the latest of many to be written on the theme that Oswald was innocent and that a conspiracy by others was successful in killing the President.
