Thursday! Jerry came at this point, we got started on other things, including his driving me on an errand, during which we talked about some of the things he had come for and with this in the back of my mind, without setting out to rethink it, I decded against e-mail on the fear it might be misunderstood. I have only a few minutes before 'leave for my walking and shopping and not long after I'M home, perhaps only a little while after 'skim the papers, which is all I do now, I have to leave for the garage and a possible repair, the time kearning that takes plus the time for greating ond oil change at te least, so I may not be able to compelete and mail this then.

In an effort to make the special problem comprehensible, I go back to the old saying about walking in the other brave's maccassins. Unless one has lived with my porblems and my age they may not be Beasy to understand. With the best of intentions but without the right moccassins, I can't use the nicer printour for several reasons. One is that my busy friend, a lawyer, will look at that hulk and get twrned off because of the impression he will have of the time it will take to read it. Another is that I can't take it and got a copy made without

at the least twice as much time. Another is that Mc night and others just do not have the xtra space. Jerry has been talking about running out of spec for some time as he adds to the great volume he had for th bo bks on which he is wirking And perhaps wrost of all, any publisher looking at the bulk of that manuscript will usually reject it immediately and on that basis alone.

It is almost time to leave. So, on that basis alone, I'm going to get a copy made of the manuscript copy that has the corrections indicated, before you made them. I can's find the corrected, retyped one, if there was one. What I need is the size you have been doing, regardless of any font problems. Just an ordinary, double-scapce prinout One that will fit in an ordinary stationary hox which are carce as hen's teeth hereabouts.

I will still want one in that size for my own overflowing files and I think one to send to Richard in the event he thinks he can interest a publisher, Que without all the corrections showing. I'll write and tell him that will be coming.

These are problems you had no reason to be aware of but they are, alas, real. The clean copy would be for him to show any publisher he approaches.

I do appreciate, very much, all that you are doing and I regret that this extra effort did not work out as you had in mind.

To illustrate how real the question of size is, in Jarry's The Last Crusade the publisher had him remove what remains a sect that I had given Jerry. The publisher said it was to exhibe him to keep the price down. I had the inventories of all the FB's field offices of the files they had on King. Comes to 402 pages! Only /nwwwforce Field office only, not HW. And never published. On publication it turned out that the real reason was to increase profits because the book is small, much smaller than can be sold at that price.

I hope you are not offended. Under ordinary circumstance what you did would have been fine, an improvement, but not for the prading of a lawyer who may get \$500 an hour for his time and not for the reading of a publisher who usually first pays a reader to get the reader's opinion and winds up with cost concerns from size. He also thinks in terms of editing costs. Richard' field is publishing law and he has been a publisher.

If you will please be kind enough to make and mail these two copies I'll appreciate it very much the one to Richard Priority the one to me book rate because there is no rush on that. Please just mail it without apythiog which it to Richard. There is no telling who might see it and what I've been telling you about the negative possibilities is real. I Please Litary fay the Costo.

I've been trying to evolve a decent title for the Posner/King ms but have

not come up wot hany I like. I ped plan to start reading the Hunes ARRE deposition at the garage this morning. He did perjure himself and they let him get away with it, I am certain that the "emberjof the board, and they remained subject-matter ignoramuses, saw to that.
