One of the symptoms of ^{what can turn} into Neural poisoning is that the head is less clear and mine if getting too much that way. But I've begin ^y with McKnight the transfer of the books to the Hood ^{bookstore} library. While this was part of our agreement years ago it still requires new agreement on when to put them ^{ny}. So Gerry is to take a few at a time. When he gets the new authorization, of the bookstore does, he'll be moving them all. When that happens he knows of a box of the original printing of WW and if I forget to tell him, please tell him that I want you to have one. They are lost to me in the basement but he has seen them.

I did not get the ARRB final report but I've sent you a manuscript on it written without that final report. Wish I had it to read and annotate now.

Russo's book is so ignorant, so stupid, so arrogant and self important when he is a subject-matter ignoramus it turned my stomach and I laid it aside

We have had more problems than you can imagine. I hope that we'll be able to remain here and not have to go to a nursing home. Preparing for that involved some unusual problems. Lil has a hiatal hernia and ^{in that} the bed was five inches higher at the headboard. But with the clotting in my legs I could not sleep thatway. I had to keeo my legs elevated. So, I slept on the sofa. ^y But with Lil having two patches in her left thigh I do not want her getting out of bed unattended. If somep- thing happened to her I would not hear whatever she did to get my attention. So, a fine neighbor took the bed apart and we are ~~not~~ giving it to a charity. We ~~will~~ have a hospital bed for Lil and she 'll then be able to tap me to awaken me. I'll be on a twin bed if there is room for it or on a cot.

~~XXXXXXXXXXXX~~ Our relationship has come to ~~mean~~ much to both of us personally and what you have done has become imp^ortant more than I'd believed would be possible. Can't exaggerate the value, but please do, when you can, check with me about changes so we can agree on them. There can be in some what is not within your exp^erience but is within mine, some times at least.

Just heard from Lil. The doctors hope that in about a week the clots will be gone or under control and that she'll be back in the p.t. program. She said she hopes ~~XXXXXXXXXXXX~~ she is out before you and your wife are here. We do look for ward to that. Thanks and best,
