Dear Mr. Rhoads:

Recently your office advised that some additional documents had been discovered in the Warren Commission collection which had originated in the Department of Defense. A representative of this office reviewed the Warren Commission documents which your staff made available and identified 20 different Department of Defense documents, some of them in multiple copies.

Enclosed is a listing of the Department of Defense documents discovered in the identified Warren Commission document folders. Availability for release and any applicable special notations are shown.

It was noted during this review that the Warren Commission folders which were made available contained documents which had originated in the Department of Defense but which had been sent to the Commission by the Department of State. Because of the multiplicity of copies, and also because each of the identified documents either has been published or is available in other Warren Commission records supplied by the Department of Defense directly, it is suggested that all copies of Department of Defense originated documents be deleted from the Commission folders containing documents supplied by the Department of State. This action would have the virtue of reducing quantity and would make unnecessary the sanitization of certain of the records before permitting public scrutiny. Your office was supplied with a copy of a report prepared by our reviewer dated July 29, 1965, in which the locations of multiple copies of the Department of Defense documents are stated.

In summary, all but one of the Department of Defense documents identified during this review may be included in the open records of the Warren Commission, although several require some deletions. The exception is the Edgewood Arsenal Technical Report CRDLR 3264, March 1965, which must remain Confidential. If a future request is received for permission to review or to publish certain information contained in that report, the inquirer should be directed to the Chemical Research and Development Laboratories, Edgewood Arsenal, Maryland.

We appreciate your cooperation in advising us of the presence of the additional Department of Defense documents located in the Warren Commission collection. If additional Department of Defense documents are discovered, we would appreciate being advised.
