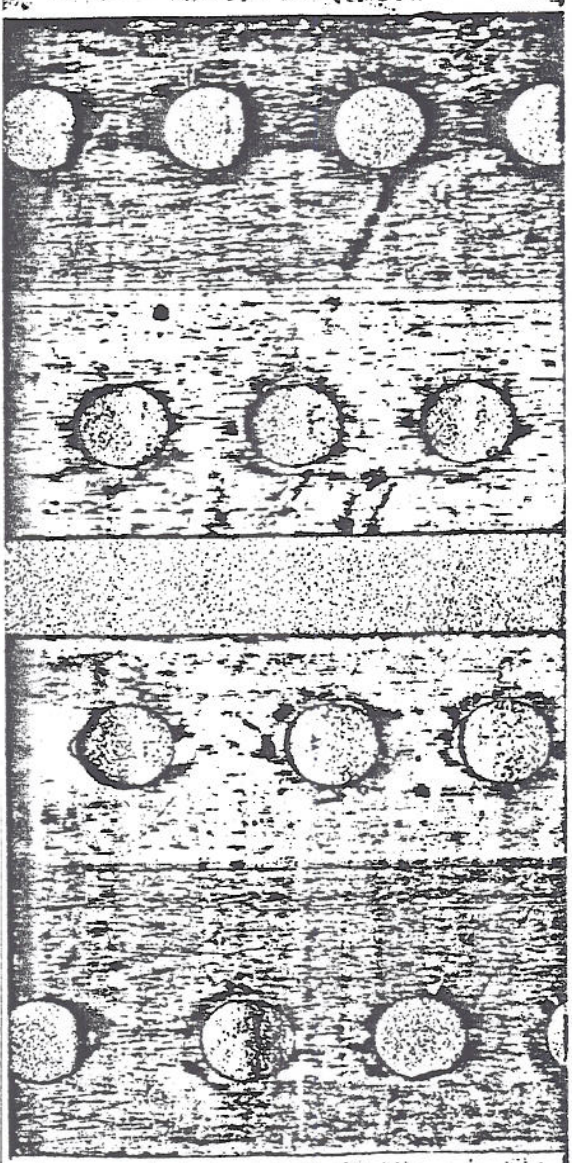

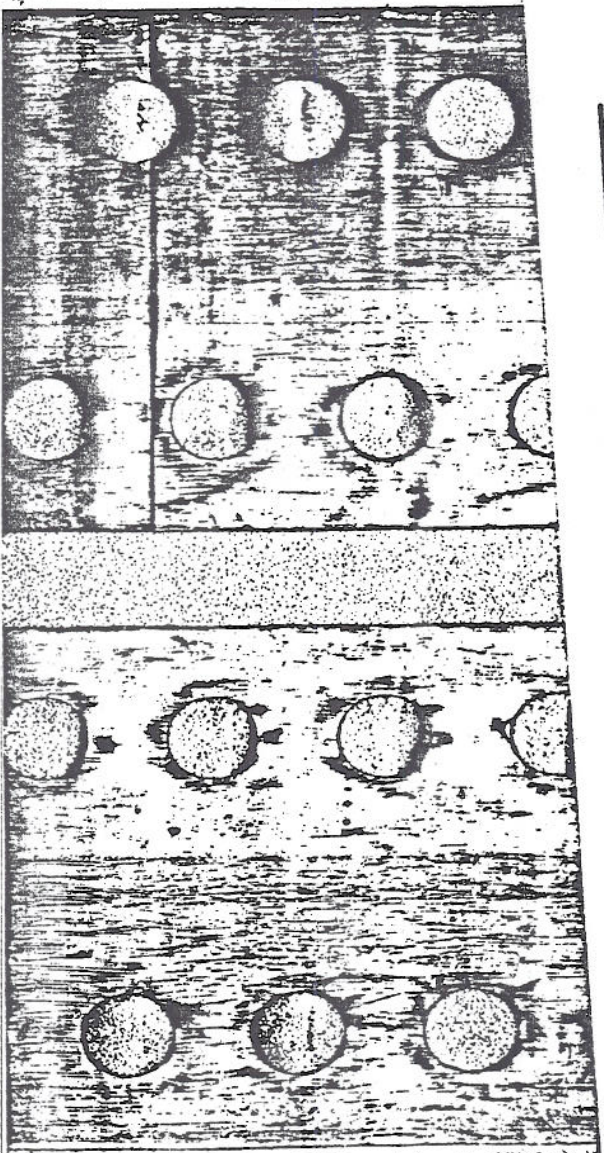

LHO studied Russian.

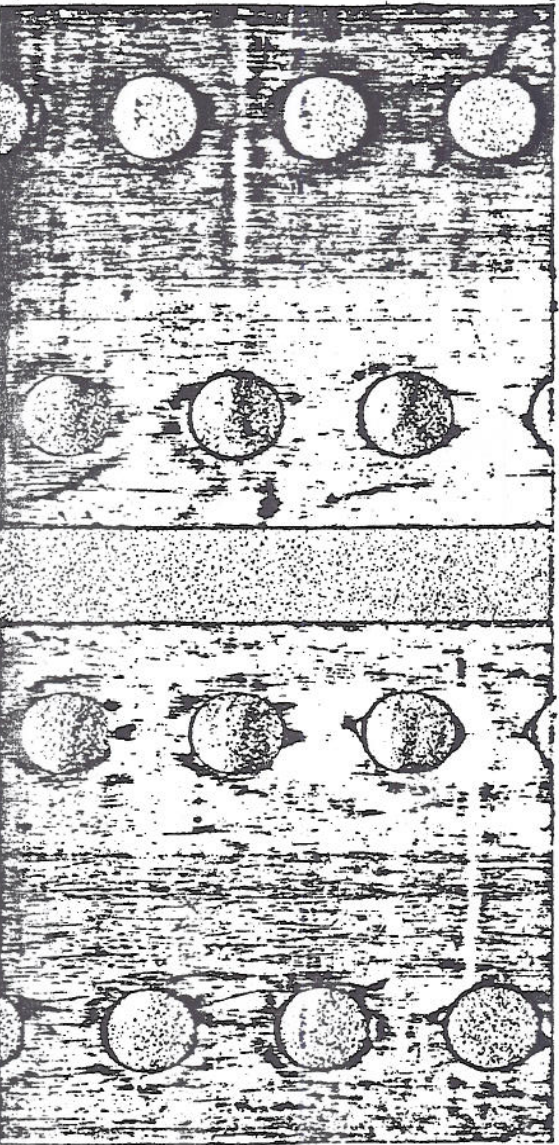
LHO addressed people "Comrade" - and he was called "Comrade Oswald" in joking fashion.

LHO was quiet person, kept to himself, never did anything to offend anyone.

LHO dated Rosalun Quinn, aunt of Roussel and an airline stewardess for Pan-Am. and got the date through Roussel who was her nephew. Rosalun Quinn was studying Russian, hence, Roussel got her the date with LHO.

Marine Corps, enlisted

Knew LHO at MACS-1 from 10 or 11/57 to 2/58. LHO was radar controller. Most of this time they were on maneuvers in the Philippines.

LHO spoke only after he was spoken to.

Robinson admonished LHO while latter on guard duty on several occasions for sitting down and reading. LHO in return made sarcastic remarks to Robinson or severely stared at Robinson as if he resented authority.

LHO had .45 Cal. automatic and had trouble removing and replacing the clip in his automatic - not familiar with this type weapon. LHO did not appear interested in firearms. Robinson did not believe LHO was expert marksman.

Robinson in same bunkhouse with LHO but not in same cubicle. He had no immediate contact with LHO.

Robinson was there when LHO shot himself and heard about it and later saw LHO with bandage on "wrist." Robinson recalled LHO shot self in wrist.

LHO was always alone - Robinson never saw anyone talking with him.

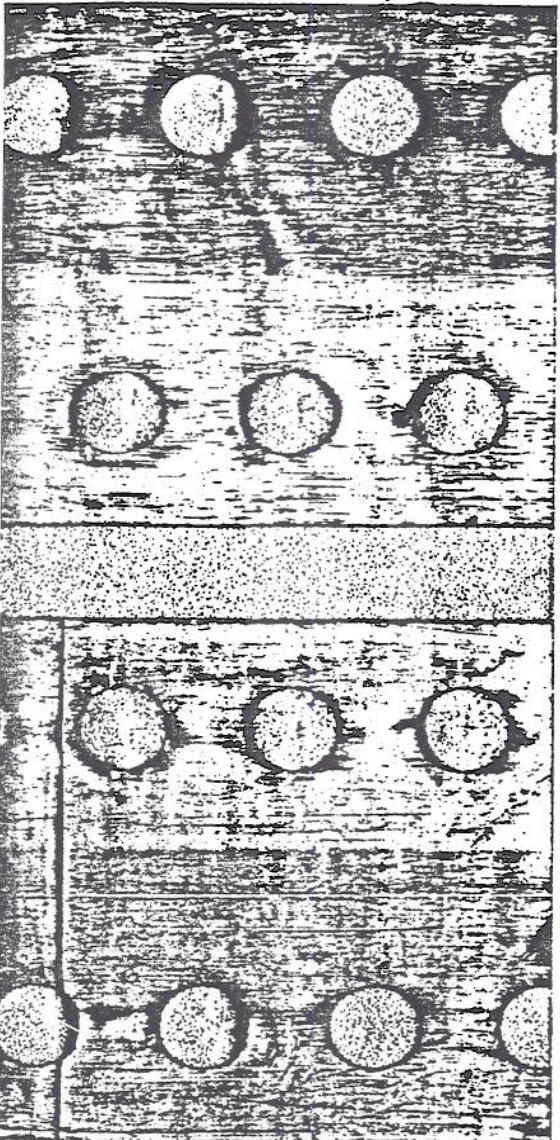

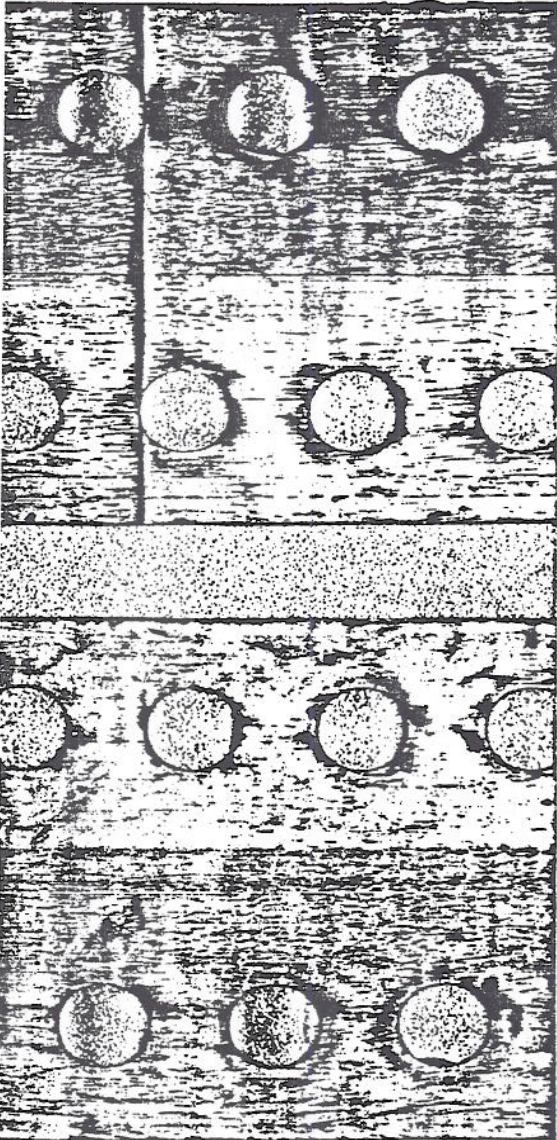


RANBERGER, Sgt. David Wallace

He knew LHO on and off from 6/57 to 5/58.

Met him in 6/57 in Jacksonville, Fla. Transferred with him to Biloxi, Miss. in 6/57.

LHO was a "loner" - never went out on liberty with the rest of group.

In 6/57 same group went to El Toro, Calif. and in 8/57 they went to Japan.

On ship Powers played chess with LHO. On ship LHO read "The Leaves of Grass" by Whitman and "Age of Reasoning." LHO preferred to remain alone and read on board the ship.

LHO went to Philippines - Cubi Point. The group guarded a U-2 there. They then went to Conigida. Before going there one of the group was killed while on guard duty. In 5/58 the group returned to Japan and LHO returned to U. S. This was last time Powers saw LHO.

Powers believed LHO had Japanese girlfriend in Japan.

Powers recalls LHO studied Russian while in Japan.

LHO was a "loner." He was antagonistic to discipline. not in sympathy with esprit de corps of Marine Corps.

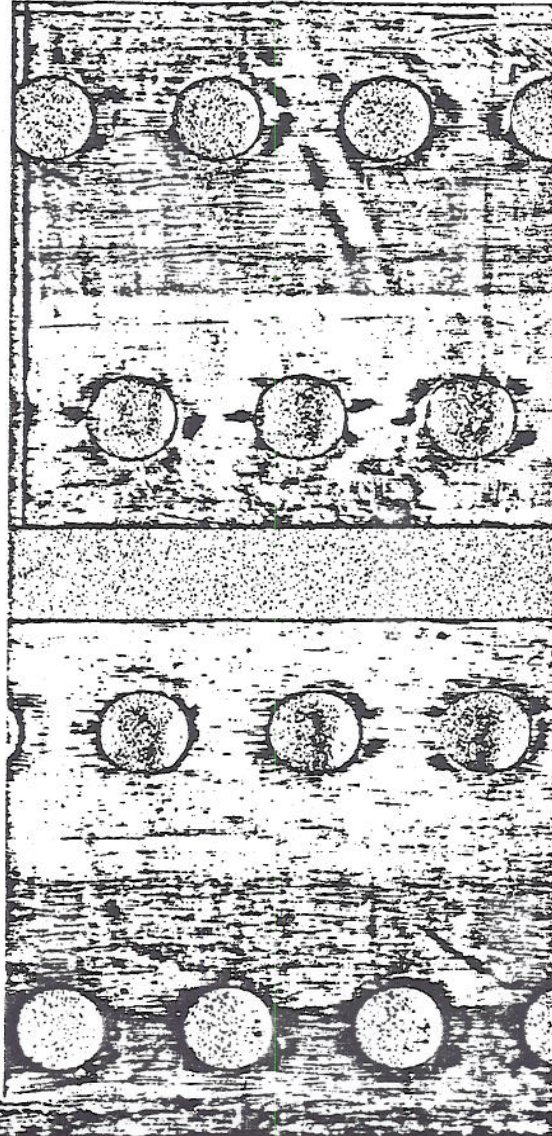

Recalled when LHO dropped derrigger at Atsugi.

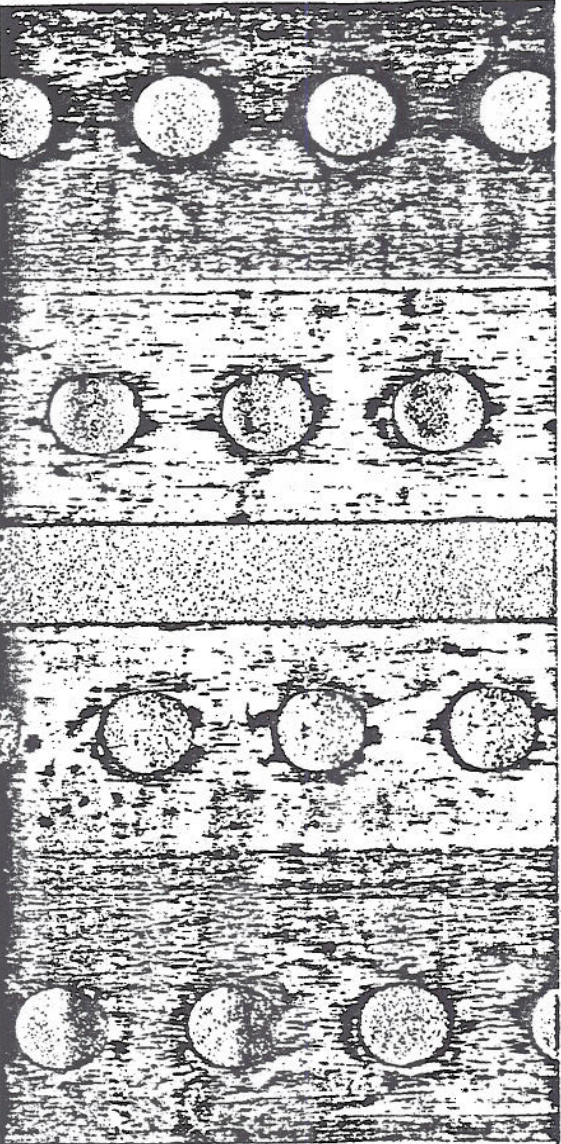
LHO drank: passed out drunk in parking lot next to barracks.

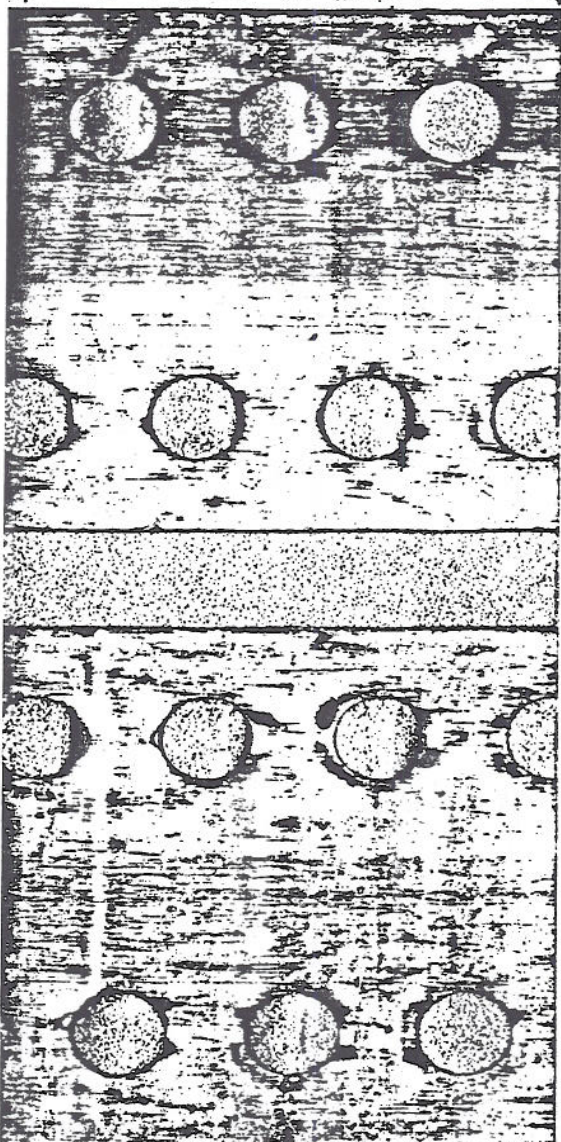
He and LHO had no common interest.

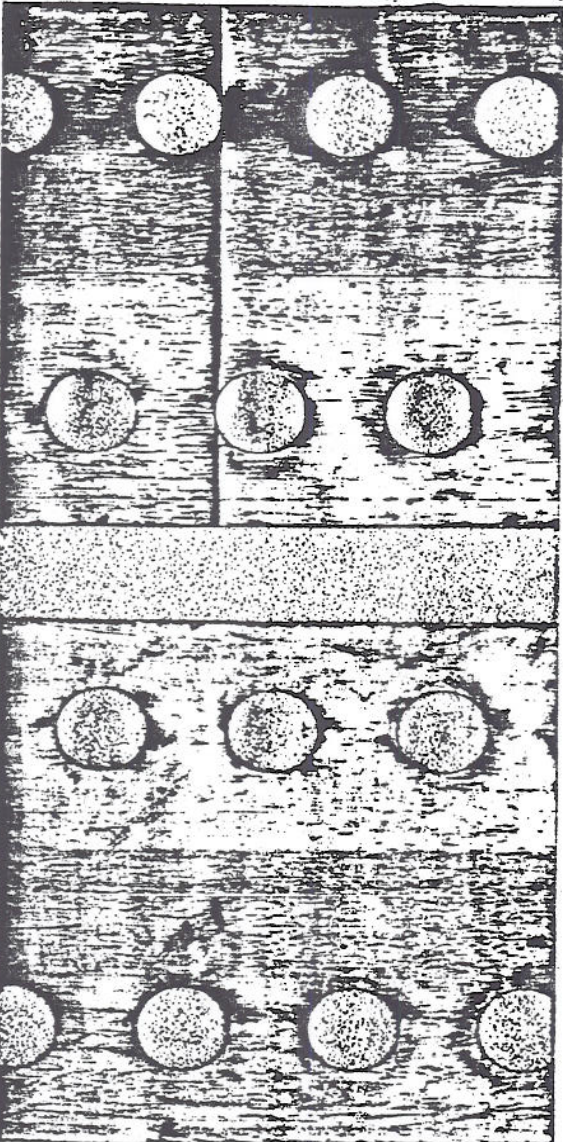
Resides in Jacksonville Beach, Fla - McKesson and Robbins salesman.

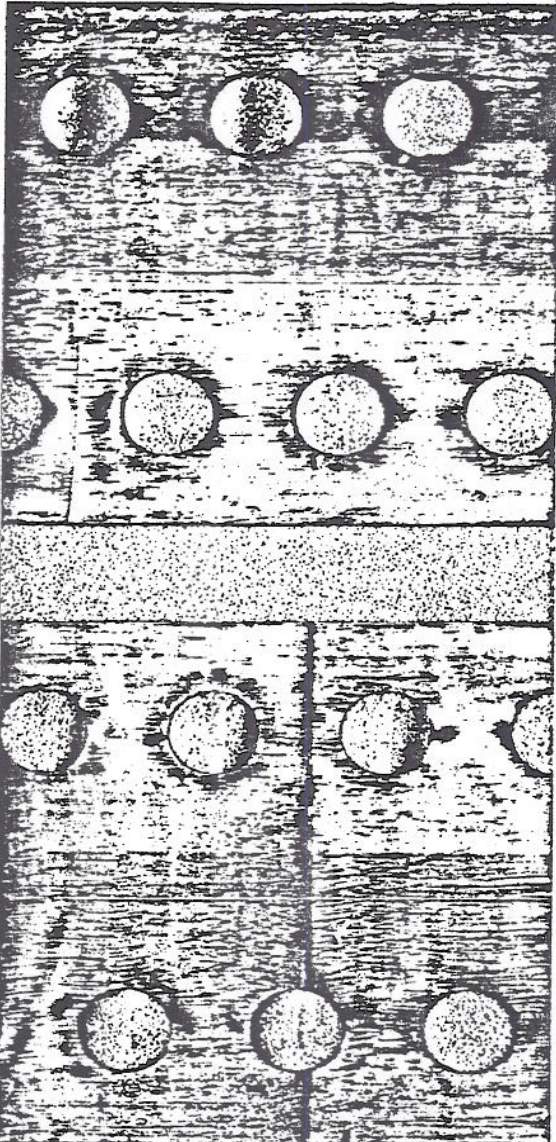

Knew LHO at MACS-9. Oswald was radar operator.

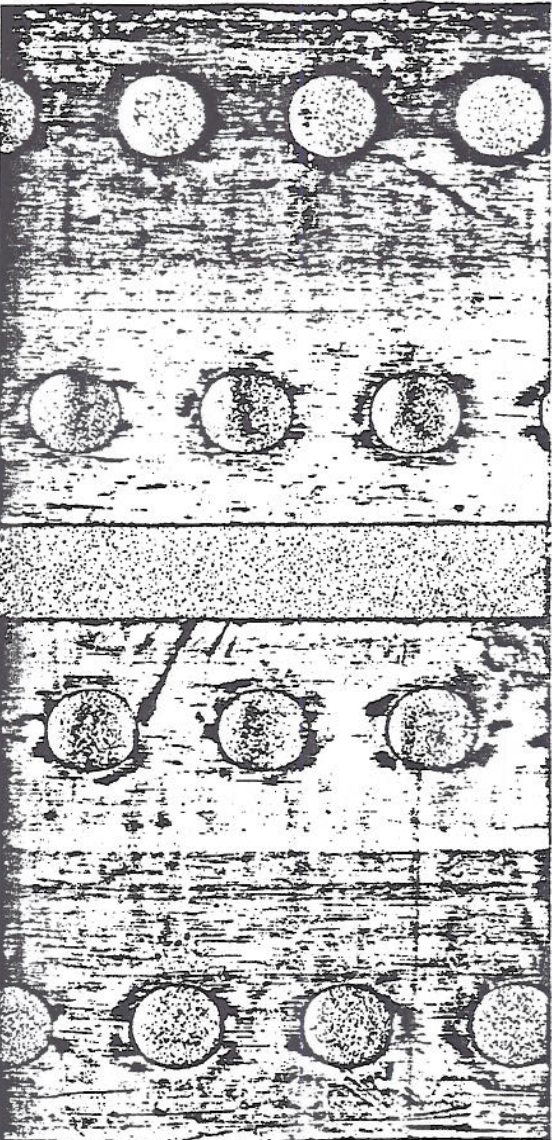
LHO was introvert - very quiet - kept to himself - did not appear to have any close friends - very seldom left the base.

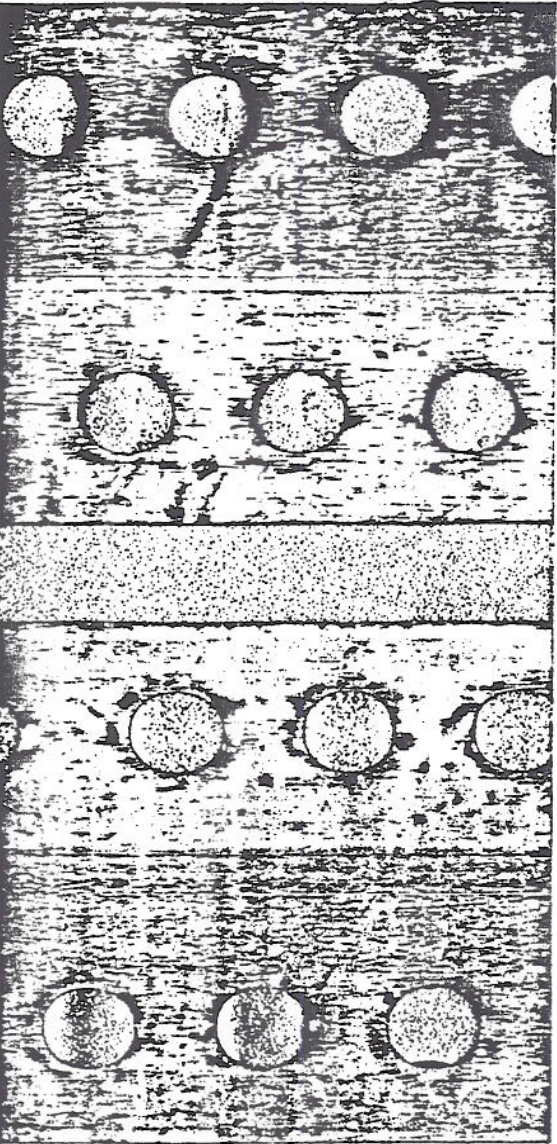

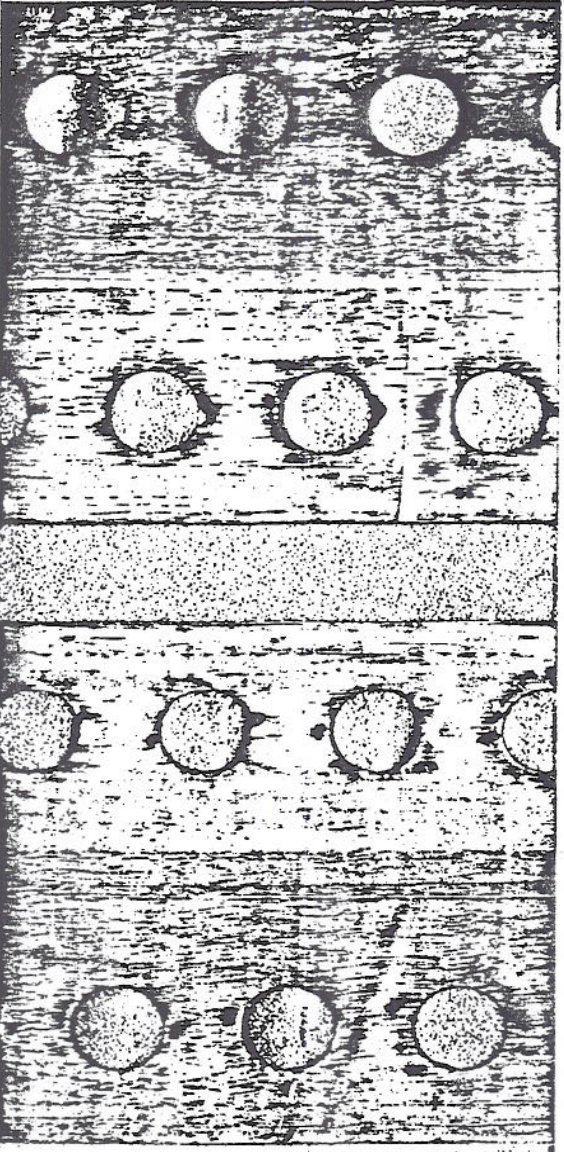
Acquainted with LHO for 6 - 8 month period in El Toro, Calif.

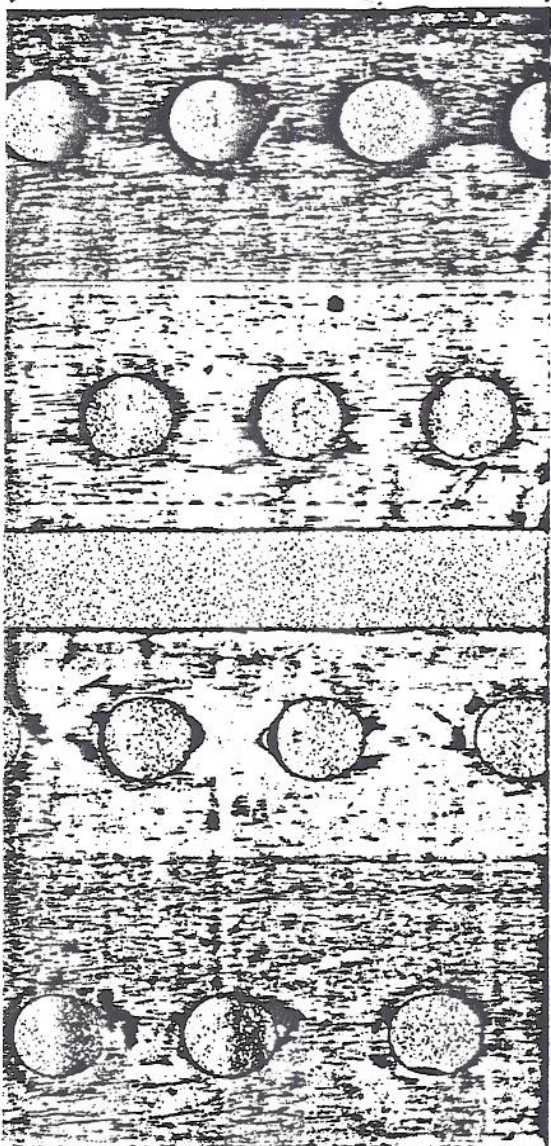
Knew LHO at Santa Ana. He was Barracks NCO with duty to inspect quarters. LHO had a private room in quonset hut which he kept locked at all times. In order to inspect the room he had to threaten disciplinary action to get LHO to unlock the door. LHO always had stacks of books on communism which he read constantly.

Practically everyone "felt sorry" for LHO as he was a "lover." He never went on liberty with any of the men. He doubted if LHO had any friends in Santa Ana area.

Spoke of one "Del Gardo" -- Nelson Delgado, probably. He resided in same quonset hut with LHO and was so uncompatible with LHO he requested to be assigned to other sleeping quarters.

Punk recalled LHO trying to get hardship discharge; later he read that LHO had applied for Russian citizenship.

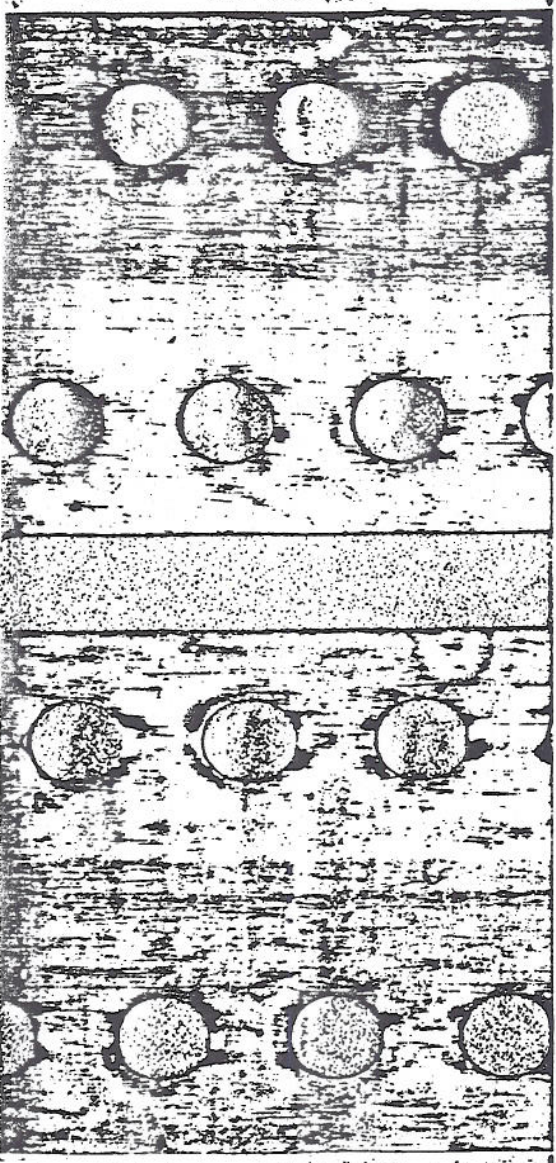
Demers lives in Lewiston, Maine.

12/13 Delgado lived in Quonset Hut 34 until he requested transfer to another hut in 6/59. LHO lived there also.

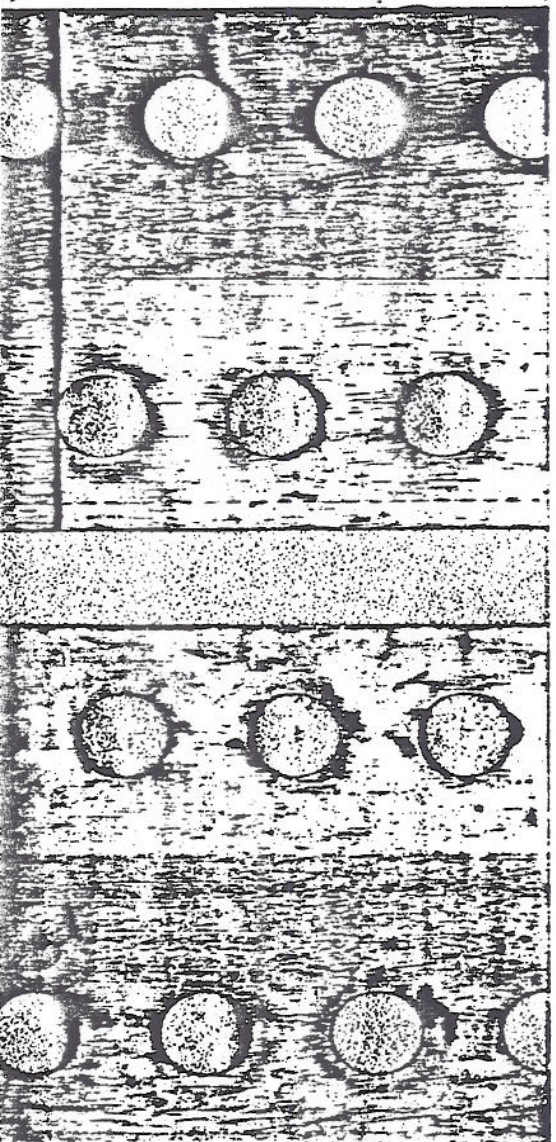
1/15 LHO's reading: Das Kapital and the Animal Farm, LHO liked classical music.

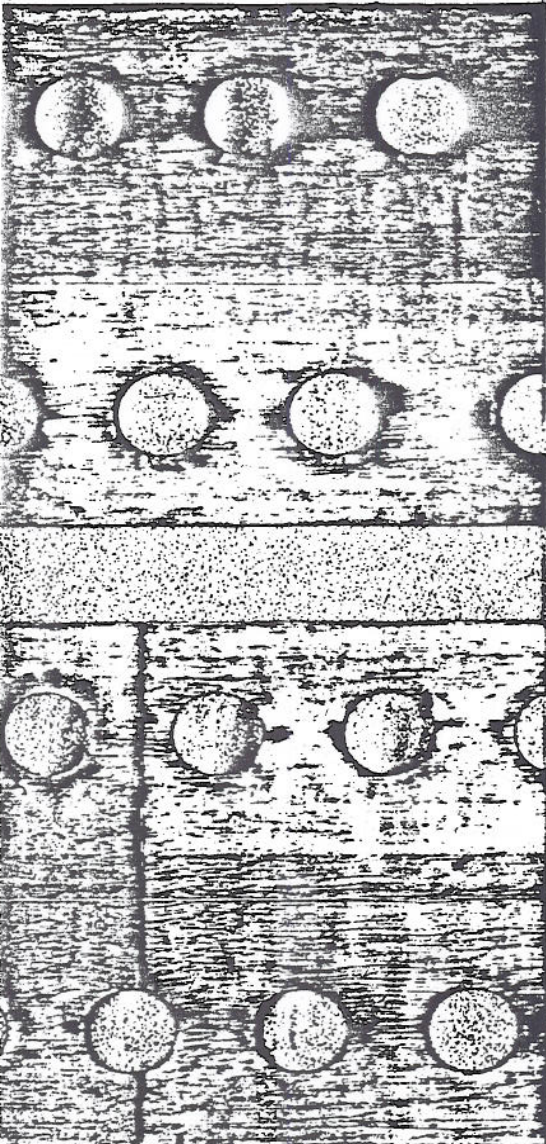

LHO had Derringer at Atsugi.

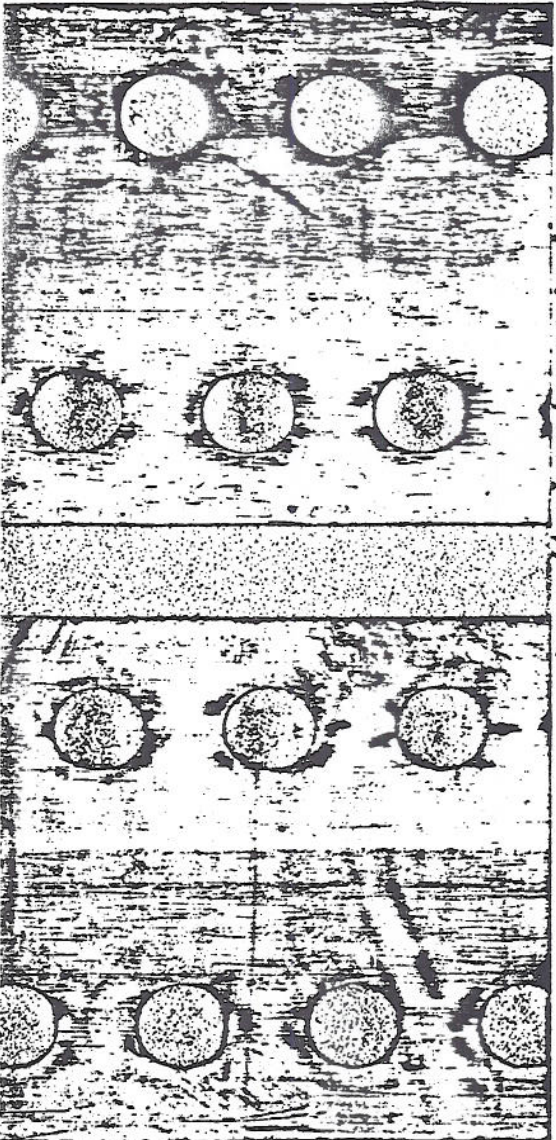
LHO was "real sloppy Marine - but had reputation as pretty good

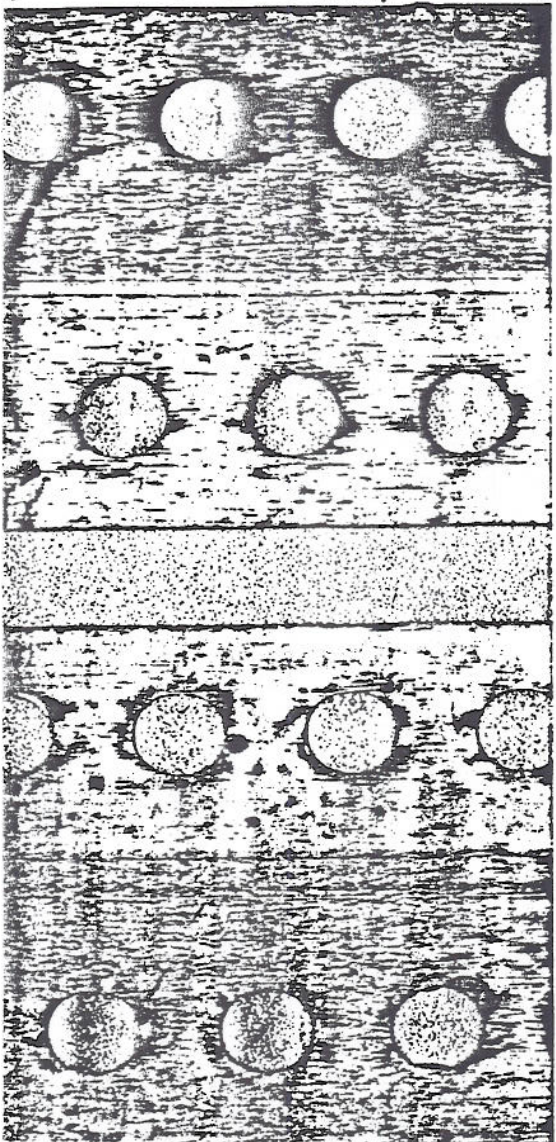
Cassisi lived in barracks which housed 72 men and LHO also lived there. Limited contact with LHO on duty and no contact with him off duty.

LHO "odd" type who liked to be alone. Cassisi had impression LHO went to Yokahama on off duty. On a few occasions LHO returned to barracks in a completely drunken condition. Came into barracks and woke up every man in barracks with his drunken shouting. Otherwise LHO was very quiet person who had no difficulties getting along with other men.

LHO was very thin while in service.

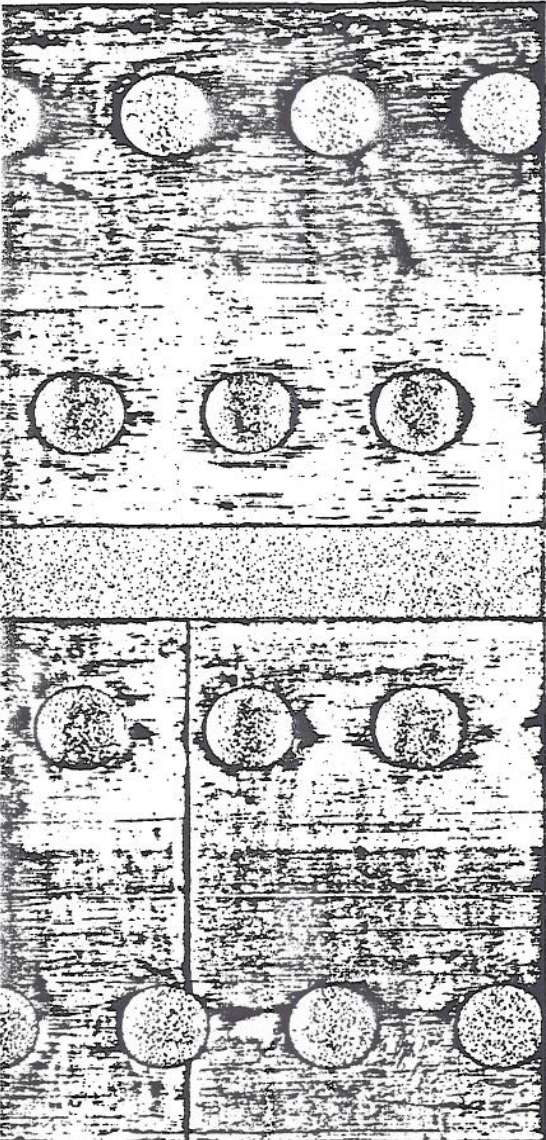
Knew LHO in Japan. Recalls LHO was arrested by Marine authorities but knows no other details about this.

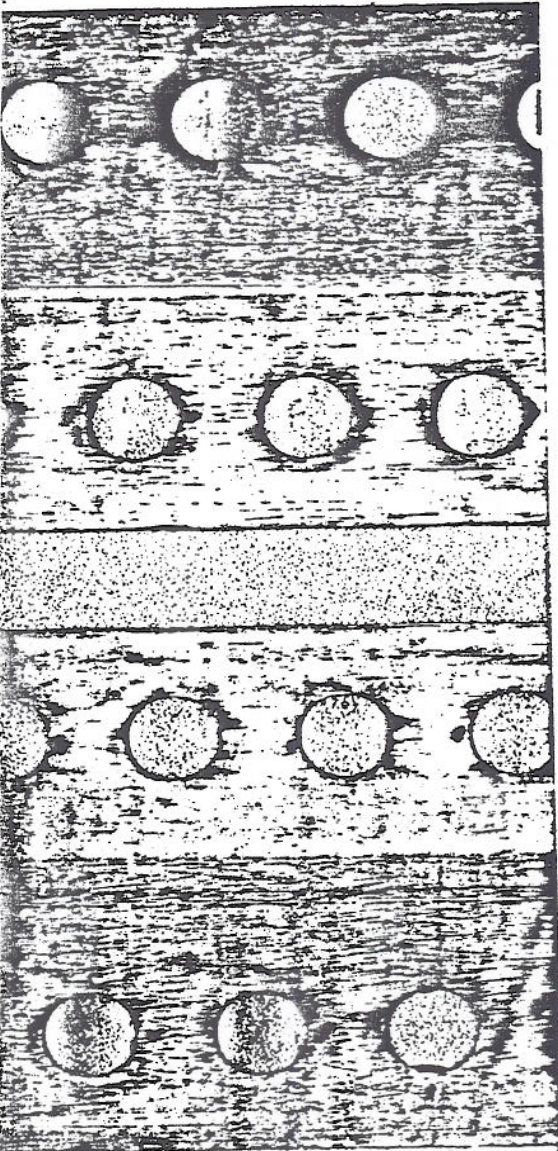

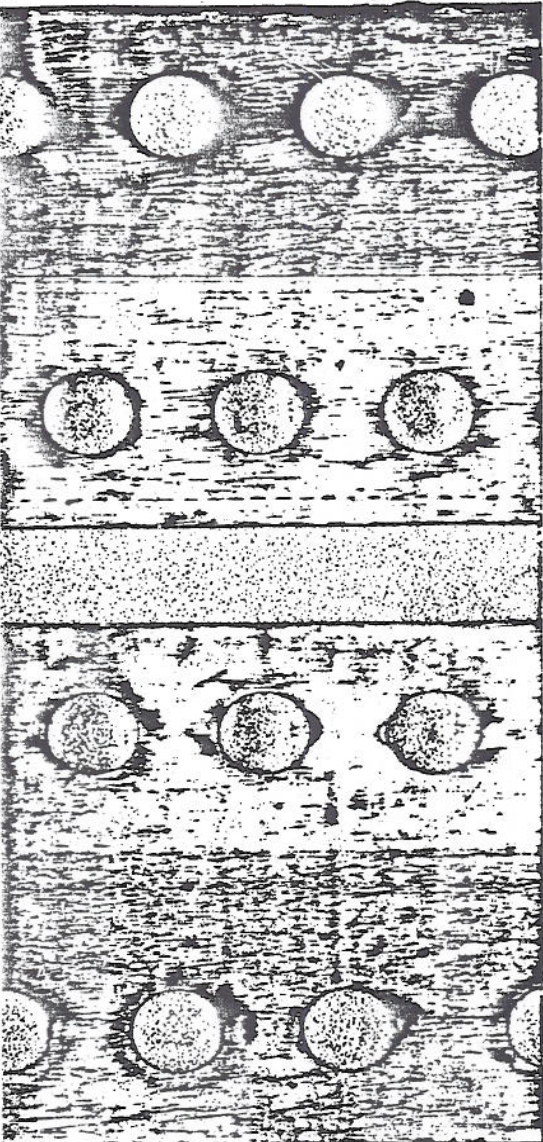
