Dear Mr. Whittier,

If your note of the 25th had come to me by now, today I'd have phoned you while I was in Washington today.

You enclosed a copy of an FBI file (with regard to memorandum, if you do not know their slang) dated 11/20/77. You asked "anything new on page 5? Not since Sprague used it on coast-to-coast TV."

Your copy is identical with mine, which means it is of Secret Service origin.

Look at the marks made. There may be an item for you in this.

You will notice that there is a line drawn from the right-hand margin, from a ?

It goes to "...the Dallas Police Department and FBI agents converged on the theater and took into custody Lee Harvey Oswald..."

Vintage Hoover, or Hooverism for Hoover. The file being in on the habbing of ~~Kennedy~~ and Dillinger. Personally, that is, young'un.

My recollection is not clear but the checking should not be difficult. So I can't say there was no FBI agent there. I can say that with the ~~mass~~ surplus of cops who needed FBI agents on a police call! The call was by Julia restal to the police, NOT the FBI.

I do not recall any FBI agents there. I do know it was a police arrest and that the FBI did NOT take Oswald into custody.

There can be other significances so I suggest that you may want to have some of your people check the illegible mark in the upper right-hand corner. My hunch is that Crowley turned this over to an agent who may have retired by now, or moved up. He is Robert Inman Bouck, who was then in charge of the White House detail. I also have a hunch that by the time the Secret Service got this Tom Crowley, then an inspector, was in or on his way to Dallas, so he did not receive it initially. I do not know if he's still there. He is Assistant Director in Charge of Presidential Protection. Unless he also has retired.

Another is: the unjustified FBI claim is a snap at the Secret Service. On this basis you might get one of your connections to give you a little.

I'll be in Washington again for Lansky's Tuesday press conference. The book even upstaged Bud, who had, I think unwisely, canceled his own. But, properly if belatedly, fears any association with Lansky. I do have questions about this when to my knowledge Lansky's book had been bought by a reporter friend of mine before he passed on 4/9/

I do not expect to ask any questions. I think Lansky may try to throw me out, and I know that with a little help some good reporters could turn this into a memorable press conference. What great fun it would be if they asked questions with the title of his book "Come Home Tarot!" - think it is.

He may have some new b.s. for the occasion. He and Abernathy have been talking for more than two weeks of sensational new developement to be disclosed in Washington. I rather suspect that ~~book~~ has been cut in on the book promotion. The book is obscene, not merely crooked.

Lansky is even telling people that I've tried to get him disbarred. I haven't but I should. It is the one good idea I've known him to have.as best I can trace it the origin of the Rauchtry effort to intimidate press is CIA - is a sh...Lansky did on WWDC about 1/25/77. Best wishes,
