MONDAY'S EXCELSIOR REPRINTED NICHOLAS HORROCK'S NEW YORK ~~SECRET~~ <sup>N.Y.</sup>  
TIMES ARTICLE IN WHICH HORROCK CLAIMED THE CIA HAD RECORDED  
A TELEPHONE CONVERSATION BY LEE HARVEY OSWALD TO THE SOVIET  
EMBASSY IN MEXICO CITY APPROXIMATELY EIGHT WEEKS PRIOR TO  
THE ASSASSINATION OF PRESIDENT KENNEDY. THE HORROCK ARTICLE  
FURTHER STATED THAT AFTER OSWALD'S CALL TO THE SOVIET UNION  
(SIC), THE FBI SUBMITTED BIO DATA ON OSWALD TO THE CIA, THE  
AMBASSADOR AND EMBASSY PERSONNEL, INS, THE NAVY AND THE FBI  
REPRESENTATIVE IN MEXICO.

2. MONDAY'S EDITION OF THE NEWS (MEXICO CITY) HAVE ADDED COVERAGE TO  
THE STORY. CITING "REPORTS SUNDAY FROM WASHINGTON" THE NEWS  
ARTICLE STATED: "THE SOURCE SAID THE CONVERSATIONS WERE  
RECORDED SEPT 27 AND 28, 1963, IN THE COURSE OF THE CIA'S  
ROUTINE MONITORING OF PHONE CALLS TO AND FROM THE SOVIET  
AND CUBAN EMBASSIES IN MEXICO CITY...." THE TAPES WERE  
ROUTINELY PROCESSED AND FILED WITHOUT ANY FURTHER ACTION  
UNTIL KENNEDY WAS KILLED, THE SOURCE SAID, WITH EITHER THE  
ACTUAL RECORDINGS OR TRANSCRIPTS OF THEM THEN BEING Brought  
TO WASHINGTON."
