JFK killing: the Yeltsin papers

DOCUMENTS given by Russian President Boris Yeltsin to Bill Clinton in Cologne could shed light on whether Lee Harvey Oswald schemed to kill John F. Kennedy while he was an American defector living in the Soviet Union, assassination researchers said.

Historian Kermit Hall, a former member of the Assassination Records Review Board, said Mr Yeltsin's surprise gift to the US President on Monday - declassified papers containing information gathered by Russian intelligence agencies about Oswald - were a "monumental breakthrough".

That board, which went out of business last September, was created to gather all known records regarding the assassination.

Mr Hall said the Russian records - which he and two other board members were unable to obtain during a trip to Russia in 1996 - could show what Oswald was thinking and doing in the years leading up to the 1963 assassination of Kennedy in Dallas, Texas.

"It's really critical," said Mr Hall, an Ohio State University historian. "This could tell us if he was scheming to do anything."

Oswald, a former US Marine, defected to the Soviet Union in 1959 and renounced his US citizenship. That attracted the attention of the KGB, which bugged his apartment in the Belarus capital of Minsk, paid neighbours to inform on him and kept Oswald and his Russian wife, Marina, under constant surveillance.

Disenchanted with his life in Russia and his menial factory job, Oswald returned to the US in 1962, settling in Dallas with his wife and baby. Some assassination researchers concluded that Oswald did not decide to kill Kennedy until he moved to Dallas.

The Warren Commission, which conducted the official US government investigation of Kennedy's slaying, concluded that Oswald was the sole gunman. Two days after the assassination, Dallas nightclub owner Jack Ruby shot Oswald to death as police were transferring him from the city jail to the county jail.

In Moscow, the Interfax news agency said Mr Yeltsin gave Mr Clinton 80 documents, which also detailed the Soviet government's reaction to Kennedy's assassination.

Retired KGB colonel Mikhail Lyubimov said the files would clear Moscow of any involvement in the assassination. He said the 1963 killing had sent Soviet

leaders into shock.

"(Nikita) Khrushchev rushed in terror to the US ambassador to say we were not involved," Mr Lyubimov said of the then Soviet leader.

Writers Norman Mailer and Lawrence Schiller were allowed to examine some of the documents, and used them for their 1995 book, Oswald's Tale. The book, tracing Oswald's life, shed no light on whether he had plotted in Russia to kill Kennedy.

US officials said the files, which Mr Yeltsin gave to Mr Clinton in Cologne, were in Russian. It is not yet clear what they contain.

Mr Clinton's National Security Adviser, Sandy Berger, said the papers would be reviewed "and all interesting elements will be made public".

Mr Hall said the files could answer some lingering questions about Oswald's activities in Russia, providing fodder for, or extinguishing, theories about whether Oswald had contacts with US intelligence officials in Russia.

"This would be extraordinarily interesting material," said Hall.

Other researchers doubt that the Minsk files will contain any blockbusters.

Gus Russo, a journalist who worked on a television documentary on Oswald, said he had seen some of the papers and they contained "zero evidence that Oswald was a spy".

"It will be very anti-climactic," he said.

The following information furnished by \_\_\_\_\_ is set forth below for the information of the Bureau as it is felt that it should not be disseminated.

On 3/11/59, \_\_\_\_\_ learned that IRVING DAVIDSON, \_\_\_\_\_ had been in contact with TOM WEBB (ph), possibly identical to former SA THOMAS D. WEBB, JR., on that date. DAVIDSON and WEBB engaged in a very vague and cryptic conversation concerning an apparent business deal involving an individual identified only as CLINT, who is possibly identical to CLINT MURCHISON, JR., of the Tecon Corporation, Dallas, Texas, for whom DAVIDSON had handled public relations in connection with the construction of the Avila Tunnel in Caracas, Venezuela, in the past. DAVIDSON indicated that CLINT was "scared to death". WEBB indicated that an individual identified only as BOB, had called him and DAVIDSON indicated that he had asked BOB to call WEBB. DAVIDSON stated "they had it for five", but DAVIDSON "dropped it to four", and indicated that "it was really three" because it would include the previous year. DAVIDSON added that after 3 years, there would be additional payments. DAVIDSON indicated that the persons with whom he had dealt talked about a "five year deal", but that it was really only three because the "first one" started next week. DAVIDSON indicated he would give WEBB the full details in private later.
