Dear Mr. Wilson,

I have just returned from a trip that included New Orleans and Dallas. As an official source I do not feel at liberty to disclose. I obtained the enclosure, a Dallas police "General offense report" and a retyped copy of what appears to be the part of a UPI story the jump of which was not included.

Were it not for this UPI story, I'd be inclined to discount the police report as a hoax, prepared by someone with access to Dallas Police forms. However, I was able to do some checking, not inside the police, where I have no sources, but with the Dallas Sheriff's Department. All the legible numbers are legitimate. They accurately reflect the descriptions the police would have used.

I spoke to your Dallas bureau. They say that for the years 1966, the more probable, or 1967, which is possible, their records are stored in boxes in the basement of their building. They suggested that you would be able to ascertain whether or not there was such a story and provide the missing end. I would like to know.

What I enclose, the return of which I'd appreciate, is a xerox of a xerox of a carbon of unknown generation. It was sent, anonymously, by one signing himself a former Dallas policeman. I also enclose a retyped copy of the typed material.

Among the things that inspire doubt are the use of the name "Eisenstein" for many, something he never did, and the names of policemen involved in the assassination story. With all the cops in Dallas, this seems to stretch it a bit.

What seems to lend credibility is your story, or what it represents as that.

David was said to have used the alias Hibel(?) He did live at that address, and Mr. Blazee. But he also left it edictly after this date, without using up all the rent he had paid in advance. The address given for Eisenstein is that of his "alias". Mrs. Blazee testified before the Warren Commission, she was not asked about any such incident, nor did she volunteer it.

Dallas, Nov. 21-(UPI)--A DALLAS BUILDER TODAY DENIED THAT HE HAD BEEN ARRESTED IN 1963 WITH LEE HARVEY OSWALD AND JACK RUBY IN AN OAK CLIFF ROOMING HOUSE -- AFTER A REPORTED ALTERCATION.

H. H. GRANT, 35, SAID HE WAS TAKEN TO THE DALLAS POLICE STATION "SOMETIME IN OCTOBER" OF THAT YEAR" FOR QUESTIONING. BUT THAT HE AND TWO OTHER MEN ALSO QUESTIONED WERE RELEASED "WHEN IT BECAME OBVIOUS THAT THE REPORT WAS A MISTAKEN ONE."

DALLAS POLICE CHIEF CHARLES BATCHELOR SAID DALLAS POLICE RECORDS SHOWED NO RECORD OF SUCH AN ARREST.

GRANT'S STORY CAME TO LIGHT RECENTLY WHEN SEVERAL DALLAS NEWSMEN GOT WIND OF THE POSSIBILITY THAT RUBY AND OSWALD MIGHT HAVE SEEN TOGETHER AT THE DALLAS POLICE DEPARTMENT. THE WARREN COMMISSION, REACHING THE CONCLUSION THAT RUBY AND OSWALD BOTH APPARENTLY ACTED ALONE IN THEIR NOVEMBER, 1963 ACTIONS, INDICATED THERE WAS NO EVIDENCE THAT LINKED OSWALD TO THE FORMER NIGHTCLUB OWNER.

GRANT, FORMERLY OF THE FEDERAL BUREAU OF INVESTIGATION IN DALLAS, DETROIT AND OTHER CITIES, NOW OPERATES A BUILDING FIRM IN DALLAS.

IT IS REPORTED THAT GRANT HAD RECENTLY VISITED NEW ORLEANS FOR QUESTIONING BY DIST. ATTY. JIM GARRISON, WHO IS CURRENTLY INVESTIGATING PRESIDENT JOHN F. KENNEDY'S ASSASSINATION, ALONG WITH RELATED EVENTS SUPPOSED TO HAVE OCCURED IN THE LOUISIANA CITY IN MID-1963. GRANT DENIED HE HAD EVER MET GARRISON AND THE DISTRICT ATTORNEY WAS NOT AVAILABLE FOR COMMENT.

GRANT DENIED THAT HE HAD EVER MET RUBY, BUT HE SAID HIS WIFE, ...  rest of story?

This brought into question headquarters, the complainant again changed her story concerning how the fight began and so all suspects were released pending further investigation.
