He said he is classified as a Radiology Resident at Parkland Memorial Respital in Dallas, where his telephone number is ME 1-5050, Extension 201.

Doctor DOCKERY and he was present during the time surgery was performed on LEE EARVEY CETALD on the mesond floor at Parkland Hemorial Mospital, on November 24, 1963, for about one hour prior to the death of the patient.
