nope your interview with JR was possible and successful by the time you get this. Gary now has the film and will be making copies you will eventually get. He is going to try and number the frames, so we can comment among each other with fixed references.

On the basis of the FBI reports I disagree with your suggestion that there were only three different views. The agents not regularly on the case made repeated reference to six different views, in at least one of which there was no Oswald. Perhaps by the time you get this you'll know why 17. That is a strange number, not divisible by three of six.

Of those things I have seen, I now know that Mark conducted one incomplete and very minor investigation of OswaldIs Mexican Tourist Card. This seems to be how Mart qualified as an "investigator", by accompanying Mark. There is no reference to Mort in themsens t meaningless two pages of it. Gary Sanders followed up three months later and left the confusing indefiniteness more confusing and self-contradictory. He was go help and cost money I think was wasted.

From the summary, there are things in here that could be of interest, i cluding the reports of Uswald's contacts with the media (names not given in summary). Are those the names in his notabook? If they are not, is there added significance in the notabook names?

That 100 block of Camp is a touchy area. It seems that the FBI interviewed no one in it until forced to by Mrs. Herard and them as I note in what I will send, ignore the 117 address in the notebook. Ronnie Caire, to whom Oswald amplied for a job, was in that block-not asked, yet he knew Oswald. Also Arcacha. Thus, with the others things in the memo, I am very interested in the balance of this document.

It may be without rignificance, but those questioned after Mrs. Herard all worked on the same side of the Cemp St, except one of the newsies at the far corner, and would have been less likely to see enything. Those on the odd side, like Gemelli, could have seen the distribution.
