LE BLANC, Manager, Piggly Wiggly Store, 7041 Canal Boulevard, residence address 6001 Music Street, advised that some time subsequent to January 1, 1964, exact date not recalled, he was looking in an old address book for the telephone number of Blue Plate Foods in New Orleans, and he discovered the notation on the front page of the notebook written in his own handwriting "LEE OSWALD 529-7181 help." LE BLANC had no idea as to when he placed this notation in his notebook and only vaguely recalls that he made this notation when an individual had applied for a position. Upon finding out that there was no job available he left his name and telephone number with LE BLANC.

LE BLANC observed a photograph of LEE HARVEY OSWALD and was unable to identify OSWALD as the individual who had applied for a position prompting him to make a notation in his address book.

JAMES L. COLLINS, proprietor, Piggly Wiggly Store, 828 Harrison Avenue, residence address 6551 Milne Street, advised that HARRY STOLTZ had mentioned to him sometime subsequent to the assassination of President KENNEDY that an individual STOLTZ later recognized as OSWALD had tried to sell him some jewelry in front of the Piggly Wiggly Store.

ALOYSIUS J. STOLTZ, also known as Harry Stoltz, salesman, Holsum Bakeries, Inc., 4700 Howard Avenue, residence address 501 West William David Parkway, Metairie, Louisiana, advised that sometime last year, exact date not recalled, an individual wearing a sport shirt and slacks approached him in front of the Figgly Wiggly Store at 828 Harrison Avenue just as STOLTZ was about to enter the front door. This person offered to sell STOLTZ several pieces of costume jewelry of different designs which he had displayed on a tray. The jewelry did not appear to be valuable, and the individual did not mention any prices except that he offered to sell the jewelry to STOLTZ "cheap." STOLTZ told him that he did not have any money and was not interested in buying jewelry.

Subsequent to the assassination of President KENNEDY, STOLTZ observed photographs of OSWALD on television and in the newspapers and immediately recognized OSWALD as the individual who had tried to sell him the costume jewelry.

STOLTZ was unable to state the date on which the above event occurred except that he remembered that it was in the warm weather because he, STOLTZ, was wearing a short-sleeve shirt. He said that he had never seen this individual before and had not seen him subsequent to the attempted sale of the jewelry.

STOLTZ observed a photograph of LEE HARVEY OSWALD and was positive that OSWALD was identical with the individual who tried to sell him the costume jewelry.
